- Enter into a written contract/agreement for additional products and services.

_____ Agent(s) can exercise the following powers:

- Endorse checks and orders for the payment of money or otherwise withdraw or transfer funds on deposit with Partners 1st FCU.

We further authorize Partners 1st FCU to rely upon this resolution until Partners 1st FCU has received written notice signed by all general partners of the Partnership of any amendment or recession thereof, and until it has acknowledged receipt of such notice Partners 1st FCU shall be indemnified and saved harmless from any loss suffered or liability incurred by it in continuing to act in accordance with this authorization.

RESOLUTIONS

The Partnership named on this resolution resolves that,

1. Partners 1st FCU is designated as a depository for the funds of the Partnership and to provide other financial accommodations indicated in this resolution.
2. This resolution shall continue to have effect until express written notice of its rescission or modification has been received and recorded by Partners 1st FCU. Any and all prior resolutions adopted by the Board of Directors of the Partnership and certified to Partners 1st FCU as governing the operation of this Partnership's account(s), are in full force and effect, until Partners 1st FCU receives and acknowledges an express written notice of its revocation, modification or replacement. Any revocation, modification or replacement of a resolution must be accompanied by documentation, satisfactory to Partners 1st FCU, establishing the authority for the changes.
3. All transactions, if any, with respect to any deposits and withdrawals by or on behalf of the Partnership with Partners 1st FCU prior to the adoption of this resolution are hereby ratified, approved and confirmed.
4. The Partnership agrees to the terms and conditions of any account agreement, properly opened by a partner of the Partnership. The Partnership authorizes Partners 1st FCU, at any time, to charge the Partnership for all checks, drafts, or other orders, for the payment of monies that are drawn on Partners 1st FCU so long as they contain a signature(s) for this purpose.
5. The Partnership acknowledges and agrees that Partners 1st FCU may furnish, at its discretion, automated access devices to authorize users of the Partnership to facilitate those powers authorized by this resolution or other resolutions in effect at the time of issuance. The term "automated access device" includes, but is not limited to, automated teller machines (ATM) and debit cards.
6. The Partnership acknowledges and agrees that Partners 1st FCU may rely on alternative signature and verification codes issued to or obtained from the Agent named on this resolution. The term "alternative signature and verification codes" includes, but is not limited to, facsimile signatures on file with Partners 1st FCU, personal identification numbers (PIN), and digital signatures. If a facsimile signature specimen has been provided on this resolution, (or that are filed separately by the Partnership with Partners 1st FCU from time to time) Partners 1st FCU is authorized to treat the facsimile signature as the signature of the Agent(s) regardless of by whom or by what means the facsimile signature may have been affixed so long as it resembles the facsimile signature specimen on file. The Partnership authorizes each Agent to have custody of the Partnership's private key used to create a digital signature and to request issuance of a certificate listing the corresponding public key. Partners 1st FCU shall have no responsibility or liability for unauthorized use of alternative signature and verification codes unless otherwise agreed in writing.
