


INTENSIVE RECRUITMENT SERVICES BUILD POSITIVE, HEALTHY RELATIONSHIPS WITH YOUTH TO UNDERSTAND THEIR STRENGTHS, INTERESTS, NEEDS, AND FAMILY PREFERENCES, WHICH INEVITABLY ENHANCES THE ABILITY OF THE YOUTH TO FIND STRENGTH AND FEEL EMPOWERED THROUGH THE PROCESS. THIS PROGRAM BUILDS ON AND REPLICATES AN EVIDENCE-INFORMED RECRUITMENT, PERMANENCY, AND FAMILY VISIT MODEL. IN THIS INITIAL YEAR, MORE THAN 220 FAMILIES HAVE EXPRESSED INTEREST IN THIS PROGRAM, AND 19 YOUTH HAVE BEEN REFERRED TO THE PROGRAM. THREE FAMILIES AND YOUTH HAVE BEEN MATCHED INTO AN ACTIVE HOSTING RELATIONSHIP.
