



THE WORSHIPFUL COMPANY OF BUTCHERS 200 CLUB

THIS IS A PRIVATE LOTTERY, OPEN TO THE WORSHIPFUL COMPANY OF BUTCHERS LIVERYMEN AND OTHER INTERESTED PARTIES, THAT WOULD GENERATE A REGULAR INCOME TO ASSIST IN THE FUNDING OF THE REFURBISHMENT FABRIC FUND FOR THE BUTCHERS' HALL, AND IN ADDITION, THERE IS A CHANCE TO WIN A CASH PRIZE EVERY MONTH!

THE PROPOSAL IS THAT ALL MEMBERS OF THE "WCB 200 CLUB" WOULD COMMIT TO A SUBSCRIPTION OF £10 PER MONTH, PER TICKET, PAYABLE BY BANK DIRECT DEBIT. ONE HALF OF THE TOTAL MONTHLY SUBSCRIPTION WILL BE OFFERED AS PRIZE MONEY. THE OTHER HALF WILL BE DONATED TO THE LIVERY BUTCHERS' HALL REFURBISHMENT FABRIC FUND. THE GREATER THE NUMBER OF SUBSCRIBERS, THE GREATER WILL BE THE PRIZE MONEY AND THE GREATER THE CONTRIBUTION TO THE LIVERY.

Example.

If 200 persons agree to contribute £10 per month, the total amount pledged each month will be £2,000.

The amount available as prize money will be a half of this total, i.e. £1,000 and the contribution to the

LIVERY HALL REFURBISHMENT FABRIC FUND will be £1,000.

Interested ?

- As a private lottery you would have to be invited to join (but please express your interest).
- You will need to complete an application form, confirming your commitment to contribute £10 per month and a point of contact for notification.
- On completion and processing, you will be allocated a "ticket number".
- The draw will take place on the first Thursday of each month at the Court lunch or dinner. If there is no event held in any particular month, the draw will take place in the office and notification of the winning ticket will be emailed to all Liverymen.

THE WORSHIPFUL COMPANY OF BUTCHERS 200 CLUB RULES

1. The object of the Club is to raise funds for the maintenance of fabric of The Butchers Hall and The Livery.
2. The Club will be run under the supervision of The Court of The Worshipful Company of Butchers who will be the Promoting Society.
3. The Club is open to all members of the Livery, their families and friends, being registered under The Gambling Act 2005 - Lotteries.
4. Members must be 16 years old or over.
5. Applicants must complete an **application form**. This will generate one "ticket number" for the applicant.
6. Entry to each monthly draw will be by subscription of £10 per month, per "ticket number", paid in advance on the 25th of every month by Direct Debit, and optionally payable on a quarterly / half yearly / annual basis.
7. Responsibility for ensuring that the subscription has been paid rests with the individual member and not with The WCB.
8. Members may apply for and be granted more than one "ticket number", provided that such a requirement is clearly indicated on the application form.
9. The draw will be held monthly, on the first Thursday of the Month at Court Lunch or Dinner and on the first Thursday of any month when there is no Court event.
10. The Prize winning amount will be paid by cheque.
11. Winners will be contacted personally by the Livery office who will make all reasonable efforts to pay the winning prize within a week of each monthly draw.
12. The Prize winning number will be emailed to the Livery, posted in the Members' section on the Butchers Hall Website after each month's draw and published in the newsletter.
13. The regular prize money will be 50% of the monthly income. There will be two monthly cash prizes. The remaining 50% of the fund each month will be allocated to The WCB Refurbishment Fabric Fund.
14. Registers will be kept recording the details of each member, the numbers allocated to them and the subscriptions received from them. (The details recorded for each member will be those as entered on their application form).
15. Unless otherwise advised, a member will be deemed to have left the Club if his/her renewal of subscription remains unpaid for a period of one month.
16. If a winner cannot be contacted, their winnings will be placed into WCB Funds after a period of 6 months.
17. The decision of the Court of the WCB shall be final in all matters requiring adjudication.
18. The Court of The WCB shall have the power to amend or revoke these rules at their absolute discretion with such reasonable notice to the 200 Club members as is necessary.
