Dear Representatives and Senators:

The undersigned civil liberties, civil rights, government accountability, and privacy organizations strongly oppose any efforts to reauthorize Section 702 of the Foreign Intelligence Surveillance Act (FISA) without an overhaul of privacy protections for people in the United States. **We therefore urge opposition to the House and Senate Intelligence Committees' FISA Reform and Reauthorization Act (S.3351/H.R. 6611), and support for the Protect Liberty and End Warrantless Surveillance Act (H.R.6570) and the Government Surveillance Reform Act (S.3234).** Considering the threat to Americans' privacy posed by the FISA Reform and Reauthorization Act, we further urge Congressional leadership to only bring legislation passed by the House Committee on the Judiciary to the floor.

As you're aware, Section 702 is an extremely controversial warrantless surveillance authority that is set to expire at the end of the year, but which will continue to operate in practice into 2024 under already issued orders, as government officials have recognized for many years.¹ Government agencies themselves admit that Section 702 surveillance has been abused to unlawfully conduct backdoor searches for information about countless Americans, including²:

- Two members of Congress, a local political party, journalists, and 19,000 political donors
- Tens of thousands of protestors from both the right and left, including "civil unrest" related to the murder of George Floyd and January 6
- Two people based on their perceived ethnic background

Other known misuses of Section 702 information further include NSA agents' searches for the communications of online dating prospects and an FBI agent's deliberate mislabeling of queries aimed at places of worship inside the United States, apparently in an effort to avoid privacy protections and oversight.³ In contrast with FBI claims that internal reforms can or have solved these abuses, the April 2023 FISA Court opinion confirms that the abuses are continuing, including recent searches for the communications of a U.S. Senator, a state senator, and a state court judge who reported civil rights violations to the FBI. The government's numbers indicate that there will be many thousands of violations each year going forward.⁴

The Protect Liberty and End Warrantless Surveillance Act is a serious and significant reform bill. It would require the government to obtain a warrant before searching Section 702-acquired data for Americans' communications, with commonsense exceptions for emergencies, consent, and certain queries relating to cybersecurity. It would also meaningfully address related surveillance practices, such as agencies' exploitation of the data broker loophole to evade legal privacy protections by purchasing sensitive information about Americans that would otherwise require a court order. And it would include important and badly needed reforms to the FISA Court.

The Intelligence Committees' legislation, however, amounts to fake reform that would in fact serve to expand surveillance of people in the United States in several alarming ways, including by expanding definitions of key terms in ways that permit more surveillance, allowing completely suspicionless searches for the communications of immigrants lawfully inside the United States, and reviving provisions of the PATRIOT Act that expired years ago.⁵ Despite claims to the contrary, it entirely fails to address alarming threats to civil rights: the bill's "evidence-of-a-crime-only" warrant requirement (i.e., a warrant requirement that does not apply when the government seeks foreign intelligence) would apply to such a tiny fraction of backdoor searches that it would be completely meaningless. Last year, of the more than 200,000 backdoor searches intelligence agencies performed, there were only 16 cases in which the FBI accessed evidence using searches that did not purport to seek foreign intelligence.⁶ The most egregious abuses of backdoor searches have involved purported efforts to find foreign intelligence. In short, the intelligence committee bills actually do more to expand surveillance than to rein it in.

Section 702 must not be reauthorized without substantial reform to rein in warrantless surveillance of Americans. We oppose the Intelligence Committees' legislation reauthorizing Section 702, and urge you only to advance legislation that has been marked up by the House Committee on the Judiciary.
