

## **ACCREDITING COMMISSION REPORT - August 2025 Commission Meeting**

Dear Members and Colleagues:

This public notice provides information regarding actions taken by the ACCET Accrediting Commission at its August 2025 meeting. Member institutions and other interested parties are invited and encouraged to submit their written comments on proposed changes to ACCET policies and standards.
