COMMITMENT LETTER

Council Is Requested To Authorize The Administrator To Sign A Funding Commitment Letter Relative To A SC RIA SCIIP Grant-Funded Project For The Headworks Of The



City Of Lake City Wastewater Treatment Plant, Pending County Attorney Review And Approval. Vice-Chairman Yarborough made the motion, and Councilman Dorriety seconded. Mr. Yokim reported that a special-called meeting of the City Council of Lake City was held on Friday, with both Councilman Springs and Mr. Yokim participating. Mr. Yokim attended virtually. During the executive session, Councilman Springs and Mr. Yokim briefed the Council on the matter at hand. Upon reconvening in open session, the City Council of Lake City voted unanimously to authorize a subrecipient agreement with Florence County. Additionally, the City Council approved assigning the project contract to Florence County, allowing Florence County to continue supporting and assisting with project oversight through its completion. The motion was approved unanimously by the members present. Councilman Caudle and Councilman Springs voted telephonically with a "YES" vote.
