Extra-Duty Requests

The Florence County Sheriff's Office can provide off-duty deputies for extra-duty requests for business and special events within Florence County. The Sheriff or Chief Deputy must approve ALL requests.

Restrictions and Fees

Florence County Sheriff's Office deputies that are working extra-duty employment are allowed to enforce all Federal and State Laws and County Ordinances. Deputies are not allowed to enforce "House Rules".

Deputies are not permitted to work at an establishment whose primary source of revenue comes from the sale of alcohol.

The hourly rate for extra-duty employment for a Florence County Sheriff's Office deputy is \$45.00 per hour (\$60.00 per hour for events requiring four (4) or more deputies, holidays and short notice (less than 24 hours)). A higher rate (\$80.00/hour) will be charged for events that require supervisor(s). If an event requires supervisors, this will be a deputy at or above the rank of Sergeant.

There is a three (3) hour minimum for ALL extra-duty employment.

If the business or special event cancels the extra-duty request within 24 hours of the scheduled event the business will be required to pay each deputy for a minimum of three (3) hours.

The Florence County Sheriff's Office requires that all extra-duty request forms be submitted at least 72 hours prior to the event.

Payments will be made to the individual deputy. Payment is due upon the completion of the event (unless prior arrangements are made).

Deputies will be required to be in uniform. Special requests for plain clothes/undercover deputies will be considered by the Sheriff.

Number of deputies required (as related to attendance):

1-100 people: 2 Deputies

101-300 people: 4 Deputies (at a rate of \$60.00/hour)

More than 300 people will require approval by the Sheriff and the number of deputies will be mandated by the Sheriff.

All events over 300 people will also require 2 supervisors at a rate of \$80.00/hour.

Sheriff may waive any of the specific requirements at his discretion.
