Sketch Plan:

PC#2025-05 Sketch Plan Approval Requested By Robert L. Weaver Located Off Of W. Sumter Street, Florence, SC, As Shown On Florence County Tax Map Number 00098, Block 01, Parcel 024.

Mr. J. Shawn Brashear, Director, Florence County Planning and Building, presented the staff report and presentation to the Commission. He stated that the property located off of W. Sumter Street abounded the City of Florence municipal boundaries in County Council District Three. The owner of record for the unzoned, thirty-nine point six acres of land (39.60) is listed as Cedar Crest Developers. Water and sewer are available by the City of Florence. It is a phased project of eighty-two lots that will adjoin an existing subdivision Phase, which is within the city limits of the City of Florence, but this parcel and phase lays over into the County. Mr. Brashear continued with the presentation and provided images of the sketch plan and the surrounding areas. When the project was first presented to staff there were questions regarding a road that connected into the City of Florence into the existing subdivision. The applicant was able to get a right of way approval from the City of Florence to connect into that existing road. The present sketch plan was reviewed at a technical review meeting and any and all issues pertaining to the sketch plan were addressed and have been resolved. The property was properly posted, and property owners were notified of the public meeting.

There were questions by the Commission.

In response to questions by the commission Mr. Brashear stated that staff had not received any telephone calls and or inquiries regarding any of the items that appeared on the agenda for the meeting.

Chairman Cheryl Floyd inquired if there were any questions and or discussion from the Commission.

There were no questions, comments and or discussion from the Commission and Chairman Cheryl Floyd opened the forum for public comments from anyone in attendance who desired to speak in support of the requested sketch plan.

Road Naming:

PC#2025-06 Request For The Naming Of A Private Road, Saddlebrook Lane, Located Off Darlington Street In Timmonsville, As Shown On Florence County Tax Maps: 00031-04-090, 00031-04-092, 00031-04-093, 00031-04-094, And 00031-04-097.

Mr. J. Shawn Brashear, Director, Florence County Planning and Building, presented the staff report and presentation to the Commission. He stated that the parcels were owned by Jim Lyles and were located in County Council District Four. The property is an existing approved subdivision of land and the owner desires to install a private road down the diagonal center line of the property. Per the Florence County Ordinance, the plat indicates that it is a private roadway that is privately maintained. It is not maintained by the County. The plat additionally indicates that no other division or subdivision can occur on the property lots, as it is a private road, that is maxed out at six lots. Additionally, no other additional access from those existing lots can be made out onto that road.

There were questions and comments from the Commission.

In response to questions, comments and discussion from the Commission, Mr. Brashear stated that there are six tracts off of the private road. That presently no road exists, and the tracts are already subdivided. The owner and applicant desire's to put in a private road and to have that road named. The private road will have to meet all Florence County road standards and will be inspected per the requirements of the Florence County Ordinance. When the road is inspected Florence County Public Works will have to ensure that no areas and or ditches are clogged that support neighboring properties.

There were no further questions, comments, and or discussion from the Commission and Chairman Cheryl Floyd opened the forum for public comments from those in attendance who desired to speak in favor of the requested road naming.

Commissioner Cheryl Floyd did not vote.

Chairman Cheryl Floyd administered the nominations and votes for the office of Vice-Chairman.

<u>Motion</u> - Commissioner Doris Lockhart made a motion and nomination for Commissioner Dwight Johnson to be appointed and to remain as Vice-Chairman for the calendar year 2025 / Second – Commissioner Glynn Willis. No other nominations were made. The vote carried 6 to 0 that Commissioner Dwight Johnson be appointed as the Vice-Chairman for calendar year 2025. Commissioner Dwight Johnson did not vote.

There were no further questions, comments and or discussion and Vice-Chairman Dwight Johnson made a motion that the Planning Commission meeting be adjourned / Second – Commissioner Karon Epps / The Commission voted 7 to 0 to adjourn the meeting.
