INSTRUCTIONS FOR ALL PUBLIC DEFENDER CLIENTS REGARDING YOUR APPEARANCE IN GENERAL SESSIONS COURT. PLEASE READ CAREFULLY AND KEEP THIS SCHEDULE, IT CONTAINS THE INFORMATION YOU NEED TO STAY INFORMED ABOUT YOUR CASE AND WHEN YOU WILL NEED TO APPEAR IN COURT.

Listed below are the terms of General Sessions Court that are currently scheduled in Florence County for the calendar year 2025:

- 1. April 7, 2025- April 25, 2025
- 2. June 9, 2025- June 27, 2025
- 3. July 14, 2025- July 18, 2025
- 4. August 25, 2025- September 12, 2025
- 5. September 22, 2025- September 26, 2025
- 6. October 13, 2025- October 17, 2025
- 7. December 8, 2025- December 19, 2025

Beginning on the Friday before each scheduled term of Court and each day thereafter through the end of each term of court you must call the court line at 843-676-8670, after 6:00 PM to find out if you are to appear in Court on the following business day. If your name is on the list you are required to be in court.

If you last name begins with the letters: A - M Press Opt. 1

N - Z Press Opt. 2

You can also find a copy of the daily list for the General Sessions court term on our website under <u>Court Dockets</u>. (Updated daily after 6:00 pm for the following business day)

As an example, you must call the Court line number on Friday, April 4, 2025 through Thursday, April 24, 2025 for the April term of court listed above. You must repeat this procedure for each term of Court listed thereafter until your case reaches a final disposition. If your case is not over and is still pending after the last term of Court listed above, it will be your responsibility to come into the Public Defender's office and obtain a new Court schedule for future months.

IF YOU FAIL TO FOLLOW THE INSTRUCTIONS IN THIS LETTER AND YOU MISS A COURT APPEARANCE, THE SOLICITOR WILL ISSUE A BENCH WARRANT FOR YOUR ARREST. IF YOU NEED FURTHER EXPLANATION CONCERNING THIS LETTER THEN IT IS YOUR RESPONSIBILITY TO COME IN PERSON TO THE PUBLIC DEFENDER'S OFFICE AND ASK FOR ASSISTANCE. IF YOU ARE INCARCERATED AND HAVE RECEIVED THIS LETTER THEN YOU WILL NEED TO FOLLOW THE PROCEDURES LISTED IN THIS LETTER IF YOU ARE RELEASED FROM INCARCERATION AND YOUR CASE IS STILL PENDING.
