Leona Beane is Professor Emeritus of Law at Baruch College (City University) in New York City, where she taught for 21 years. Professor Beane received her B.B.A. and M.B.A. from the City College of New York, M.S. from Columbia University and J.D. from New York Law School. She has been a practicing attorney involved in estates, guardians and A.D.R., and is an active member of several bar associations. She has chaired and/or lectured at several programs over the years for the New York State Bar Association: "Drafting Corporate Documents for the Close Corporation," "Forming and Advising Businesses" and others. She chaired and lectured at programs on guardians and Article 81 of the Mental Hygiene Law, having lectured in different parts of the state for several different Bar Associations. She has served on the Executive Committee of the Dispute Resolution Section of the New York State Bar Association for 10 years, and has been chair of its Committee on Mediating Trusts, Estates, Guardianships and Elderly Disputes. She has been a member of the New York chapter of the National Academy of Distinguished Neutrals.

She has published several articles on various legal topics, including partnership law, contracts, guardians, guardians *ad litem* and mediation relating to estate matters and guardianship. She also is a chapter author and an Associate Editor of *Guardianship Practice in New York State* (NYSBA 1998). She has also organized CLE programs on "The Advantages of Mediating Trusts and Estates Disputes" for the NYSBA.
