What levels are available?

LEVEL	QUALIFYING THRESHOLD	SAVINGS PER NEW MEMBER
Level 1	10 Members	4%
Level 2	30 Members	6%
Level 3	75 Members	8%

When did this program begin?

The pilot program launched in 2024. It is now in its second year as of June 2025.

When are these discount codes valid?

The savings codes will be valid from July 1, 2025 - December 31, 2025.

What if I forget to use my discount code?

If someone from a participating firm joins IIDA during the campaign period and does not use the discount code, no refunds will be issued.

Who can participate?

Any new or lapsed designer or employee of a participating firm that has never held a membership with IIDA - *or* - that has not held a membership with IIDA for 2 years or more. The following membership categories are eligible to participate Associate (1-6), Professional, International Associate, International Professional, International Dual, Educator Associate, and Educator Professional.

What qualifies as a 'Firm'?

A firm includes architectural firms, interior design studios, and educational institutions. Manufacturers, dealers, suppliers, and those who qualify as a Corporate Industry membership (corporate or individual) do not qualify.

How can I access the next level of savings?

Firms are entering the membership campaign at a threshold based on the number of their employees that are active IIDA members as of June 1, 2025. Regardless of how many employees from a firm join IIDA during this campaign period, your company's savings will remain at the same percentage through December 31, 2025. This means that even if you enter the next threshold, the discount will not increase until next year's campaign. Refer to the 'What Levels are Available' FAQ section to review the qualifying thresholds.

I am an employee at one of the participating firms, where do I get my savings code?

Qualifying new IIDA members can access the savings code by contacting their firm's interiors Principal, Head of Interiors, or Department Lead as well as by contacting IIDA HQ Member Services at memberservices@iida.org or 312-467-1950.
