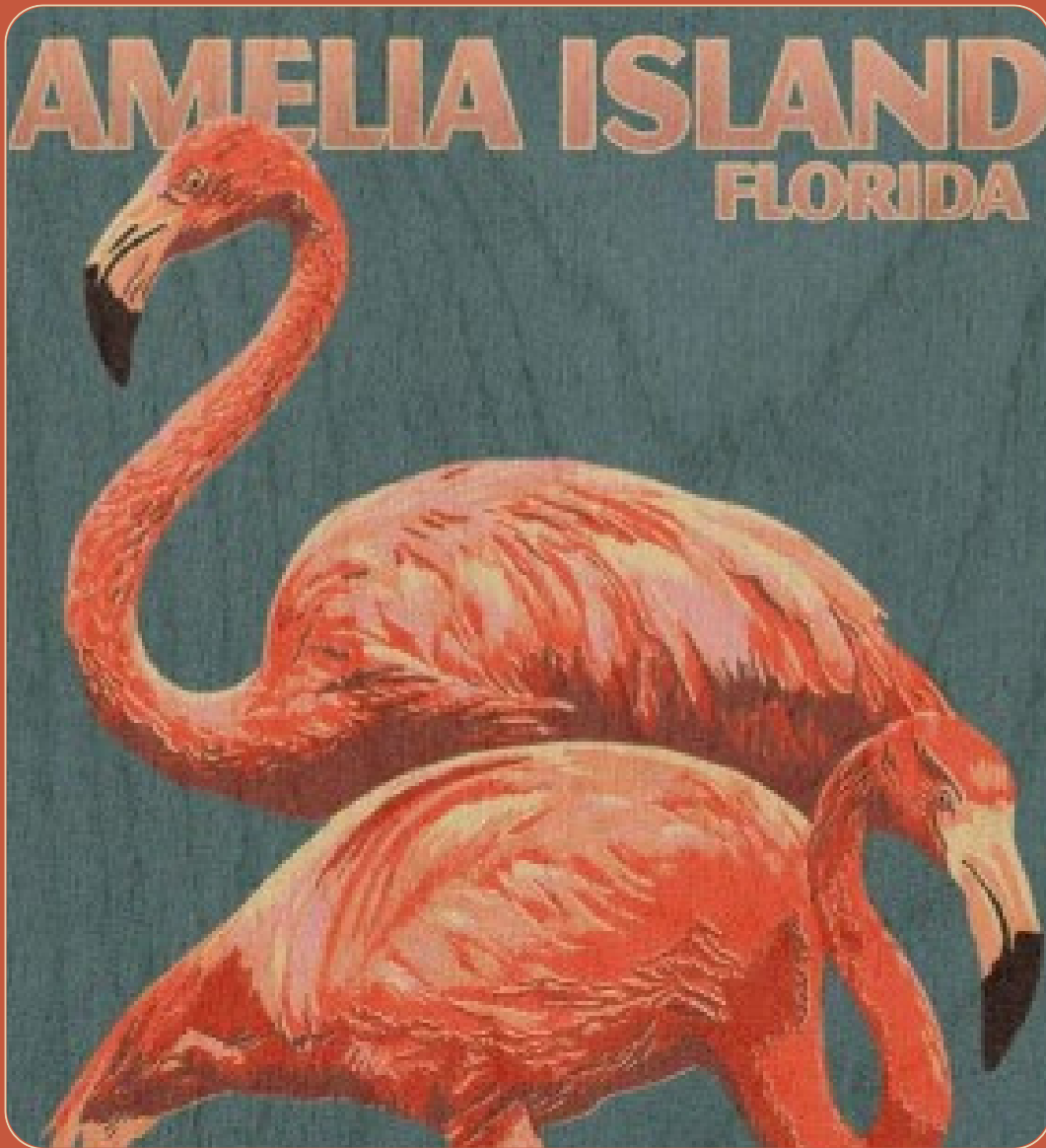

Volunteer attorneys will meet with seniors to draft and execute a will, power of attorney, designation of health care surrogate, or living will.
