

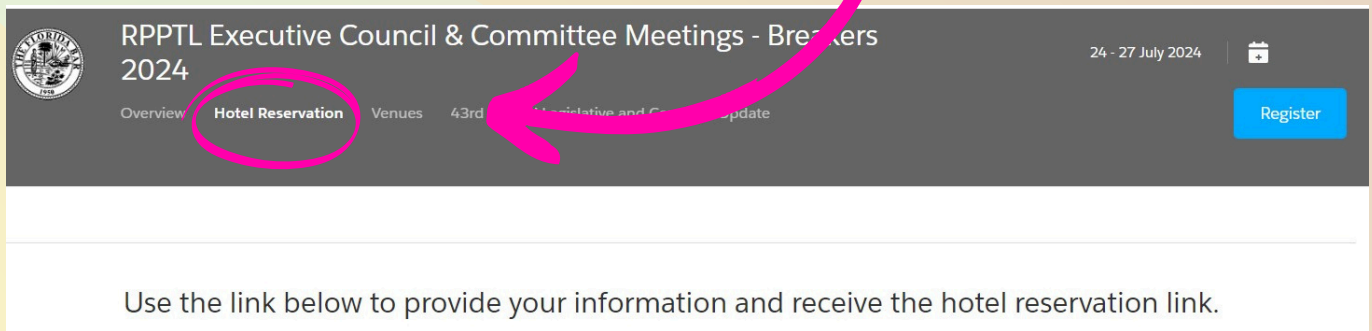

THE BREAKERS HOTEL RESERVATION GUIDELINES AND DEADLINES
