TERMS & CONDITIONS

- **OPEN TO HARLEY OWNERS GROUP (HOG) MEMBERS OF THE 50 UNITED STATES (INCLUDING DISTRICT OF COLUMBIA), 18+ YEARS OF AGE.**
- **PHOTOS SUBMITTED FOR THIS CHALLENGE MAY BE AVAILABLE FOR VIEWING ON THE INTERNET BY A WORLD-WIDE AUDIENCE.**
- **INDIVIDUALS PARTICIPATE IN THIS CHALLENGE AT THEIR OWN RISK. DO NOT BREAK THE LAW OR ENDANGER YOURSELF OR OTHERS WHEN TAKING PHOTOS OR OTHERWISE PARTICIPATING IN THIS CHALLENGE.**

SPONSOR: Harley-Davidson Motor Company, Inc. ("Sponsor"), 3700 W. Juneau Ave., Milwaukee, WI 53208.

ELIGIBILITY: To participate in Harley-Davidson's 50 Rides, One Nation Destination Ride Challenge (the "Challenge"), you must be, as of the time of entry: (i) a legal U.S. resident 18 years of age or older and have reached the age of majority in your respective state of residence, and (ii) a full or associate Harley Owners Group ("HOG") member. Employees of Sponsor and its participating dealers and retailers, affiliates, sales representatives, distributors and promotional and other vendor agencies, their respective parent companies, affiliates, subsidiaries, service agencies, independent contractors involved in the promotion, and the immediate family (parent, spouse, including common law spouse, sibling, child, grandparent, grandchild, regardless of where they reside) and household members of all such employees, are NOT eligible. Challenge is subject to all federal, state, and local laws and regulations. Void where prohibited or restricted by law.

CHALLENGE PERIOD: The Challenge begins on January 1, 2020. While Sponsor anticipates that the Challenge will be a multi-year program, Challenge is subject to yearly renewal at Sponsor's sole discretion. Sponsor will provide notification to HOG members at H-

D.com/Ride365 at least six months before the end date of the Challenge. All Challenge photos must be taken during the Challenge Period.

HOW TO PARTICIPATE: Eligible HOG members may participate in the Challenge by logging into their HOG account and going to h-d.com/ride365 during the Challenge Period. (If you do not have a HOG account, please go to h-d.com/hog to set up a free account.) To submit an entry for approval, scroll down to and enter the “50 Rides, One Nation” section on the Challenge website (h-d.com/ride365). To have a valid entry you must (1) select the ride you have completed from the dropdown list of possible rides and (2) upload a photo of yourself holding a then-current cover of the Membership Guide or Ride Guide at the Challenge check-in location for that ride as described in the Membership Guide. Please see below for additional instructions regarding photo submission requirements.

- 7) Connecticut: Litchfield Hills Loop
Check-in Point: West Cornwall Covered Bridge (photo includes all or part of red covered bridge)

- 8) Delaware: Bayshore Byway
Check-in Point: Air Mobility Command Museum exterior sign (at Dover AFB)
- 9) Florida: Southernmost Point (Overseas Highway to Key West)
Check-in Point: Southernmost Point concrete buoy (in Key West)
- 10) Georgia: Suches Loop
Check-in Point: Vogel state park sign (in Blairsville, GA)
- 11) Hawaii: Hana Highway
Check-in Point: “Halfway to Hana” sign (in front of roadside refreshment stand called Halfway to Hana)
- 12) Idaho: Lolo Pass
Check-in Point: Lolo Pass Visitor Center sign
- 13) Illinois: Ohio River Scenic Byway - IL
Check-in Point: Giant Superman Statue in Metropolis, IL
- 14) Indiana: Indiana Lincoln Highway Byway
Check-in Point: Giant Egg statue in Mentone, IN
- 15) Iowa: Historic Hills Scenic Byway
Check-in Point: Van Buren County Courthouse (all or part of building or sign)
- 16) Kansas: Flint Hills Scenic Byway
Check-in Point: Tallgrass prairie national preserve sign
- 17) Kentucky: Red River Gorge Scenic Byway
Check-in Point: Natural Bridge State Resort Park sign (in Slade, KY)
- 18) Louisiana: Creole Nature Trail Scenic Byway
Check-in Point: Creole Nature Trail Adventure Point sign and/or building (in Sulphur, LA)
- 19) Maine: Acadia National Park Loop
Check-in Point: Acadia National Park sign (at visitor center)
- 20) Maryland: Journey Through Hallowed Ground Byway
Check-in Point: Catoctin Mountain Park sign (in Thurmont, MD)
- 21) Massachusetts: Mt. Greylock Scenic Byway
Check-in Point: Veterans War Memorial tower (at summit of Mt. Greylock)
- 22) Michigan: Tunnel of Trees
Check-in Point: Leggs Inn historical marker (in front of Leggs Inn, Cross Village, MI)
- 23) Minnesota: North Shore Scenic Drive

Check-in Point: Split Rock Lighthouse (at Split Rock Lighthouse State Park, Two Harbors, MN)

24) Mississippi: Natchez Trace Parkway

Check-in Point: Natchez Trace Parkway sign (located near parkway entrance, Natchez, MS)

25) Missouri: Bagnell Dam Loop

Check-in Point: “Welcome to Bagnell Dam” billboard (at south end of dam on Bagnall Dam Blvd.)

26) Montana: Going-to-the-Sun Road

Check-in Point: Logan Pass sign (located at Logan Pass Visitor Center at summit)

27) Nebraska: Sandhills Journey Scenic Byway

Check-in Point: Sandhills Journey/Nebraska Byway sign (at any location along byway)

28) Nevada: Extraterrestrial Highway

Check-in Point: Little A’Le’Inn sign (in Rachel NV – note address is sometimes listed as Alamo NV)

29) New Hampshire: Kancamagus Highway

Check-in Point: Kancamagus Highway sign/marker

30) New Jersey: Bayshore Heritage Byway

Check-in Point: Cape May Lighthouse at Cape May Point State Park

31) New Mexico: Enchanted Circle Scenic Byway

Check-in Point: Vietnam Veterans Memorial sign (in Angel Fire, NM)

32) New York: Cayuga Lake Scenic Byway

Check-in Point: Taughannock Falls Overlook (photo of waterfall or sign) at Visitor Center

33) North Carolina: Hellbender 28

Check-in Point: Fontana Lake from scenic overlook (photo of lake itself from the scenic overlook)

34) North Dakota: Roosevelt National Park Loop

Check-in Point: Roosevelt National Park entrance sign (at any of the park entrances – signs may differ)

35) Ohio: The Triple Nickel – Ohio Route 555

Check-in Point: OH-555 sign (any of the 555 route signs between Brush Creek and Little Hocking, OH)

36) Oklahoma: Talimena Scenic Byway

Check-in Point: “Talimena Scenic Drive/Ouachita National Forest” sign (at AR/OK state line)

- 37) Oregon: Historic Columbia River Highway
Check-in Point: Vista House (building itself or sign) – in Corbett, OR
- 38) Pennsylvania: Laurel Highlands Scenic Byway
Check-in Point: Ohiopyle State Park sign (in Ohiopyle, PA – any sign is OK as there are more than one)
- 39) Rhode Island: Ocean Road to Point Judith Lighthouse
Check-in Point: Point Judith Lighthouse in Narragansett, RI
- 40) South Carolina: Cherokee Foothills Scenic Byway
Check-in Point: “Peachoid” water tower in Gaffney, SC (water tower shaped like a giant peach)
- 41) South Dakota: Badlands Loop Scenic Byway
Check-in Point: Badlands National Park sign (at any of the park entrances)
- 42) Tennessee: The Dragon
Check-in Point: Deals Gap Motorcycle Resort “The Dragon” sign (at resort in Robbinsville, NC)
- 43) Texas: The Twisted Sisters
Check-in Point: any sign showing Ranch Road 335, 336, or 337 (Ranch Road is often abbreviated as “RR”)
- 44) Utah: Monument Valley to Bluff Scenic Byway
Check-in Point: Mexican Hat rock formation (visible from US-163 near Mexican Hat, UT)
- 45) Vermont: Scenic Route 100 Byway
Check-in Point: “Ben & Jerry’s Ice Cream: Factory Tour” sign (in Waterbury, VT)
- 46) Virginia: Skyline Drive
Check-in Point: Shenandoah National Park/Skyline Drive sign (any park entrance station/signs may vary)
- 47) Washington: North Cascades Scenic Highway
Check-in Point: North Cascades National Park sign (at either end of park or at visitor center – signs vary)
- 48) West Virginia: Highland Scenic Highway
Check-in Point: “Highland Scenic Highway” OR “Monongahela National Forest” sign (any of the signs along byway or at its overlooks – signs vary)
- 49) Wisconsin: Door County Coastal Byway
Check-in Point: Goats on grass rooftop at Al Johnson’s Swedish Restaurant in Sister Bay, WI (or sign at restaurant if goats aren’t grazing on roof)
- 50) Wyoming: Beartooth Pass
Check-in Point: Beartooth Pass sign (reads “Beartooth Pass, Elevation 10,947”)

PHOTO SUBMISSION – REQUIREMENTS: The following requirements apply to photos submitted by HOG members at Challenge check-in locations:

- Photo Requirements:
 - ✓ You, the participant, must be in each of photo.
 - ✓ A then-current year cover of the Membership Guide or Ride Guide must be clearly identifiable in each photo. (Go to h-d.com/ride365 to download a printable version.)
 - ✓ All photos must be taken during the Challenge Period. Photos taken outside the Challenge Period are not eligible, and submission of such photos may result in disqualification at the sole discretion of the Sponsor.
 - ✓ All photos must be submitted online at h-d.com/ride365 during the Challenge Period. Limit one (1) photo per Challenge check-in location.
 - ✓ Acceptable photo formats are: **.jpg**, **.gif**, or **.png**. Each photo must not exceed 5MB in size. Images must be clear and landmarks/names/signs must be discernible in submitted prints. Photos that are blurred, fuzzy, illegible, or unrecognizable, based on the sole judgment of the Sponsor, will not be eligible.

Photos must be participant's original creation and may not include copyrighted, trademarked, patented, or previously published material. Photos requiring license or usage rights from any third party are not eligible. Photos may not display any trademarked or copyrighted brand names/logos, except those of Sponsor's brands. If necessary, participants should use their toolbar to blur out any brand names, logos, or trademarks. Photos cannot defame or invade the rights or privacy of any person, living or deceased, or otherwise infringe upon any third party's personal, proprietary, or intellectual rights. Photo cannot contain illegal or unlawful material, and must not promote bigotry, racism, harm, or discrimination. Photo must be consistent with Sponsor's reputation in the marketplace and must be suitable for audiences of all ages. Photos which, in Sponsor's sole discretion, contain any type of vulgarity or objectionable content will be disqualified. Photos that do not meet these stated criteria, or Photos that (in Sponsor's sole discretion) may technically meet the stated criteria but do not reflect the intent and the spirit of the Challenge, are not eligible. Submission of photo(s) constitutes participant's certification that

he/she: (i) is the owner of the photo, (ii) is able and authorized to submit it, and (iii) has received the consent of anyone pictured.

By submitting a photo, participant agrees to indemnify and hold harmless Sponsor, participating dealers and retailers, affiliates, sales representatives, distributors and promotional and other vendor agencies, their respective parent companies, affiliates, subsidiaries, service agencies, independent contractors, and the officers, directors, employees, agents and representatives of any of the above organizations involved in this Challenge (the “Released Parties”) from any and all claims, damages, expenses, costs (including reasonable attorney fees) and liabilities (including settlements), resulting from or relating to participant’s submission, or any information supplied or represented to Sponsor by participant.

CHALLENGE REWARDS: Participants will receive the following check-in site specific rewards for photos submitted at the each of the Challenge check-in locations during the Challenge Period:

- One (1) Digital Badge (site specific) and one (1) Challenge Coin (site specific) for each photo at each Challenge check-in location.

Participants who ride to all 50 Challenge check-in locations will receive the following:

- One (1) large, 6 inch rivet, installed at the Harley-Davidson Museum and One (1) small, 3 inch rivet, with display, sent to member’s home.

Rewards will be awarded electronically (Digital Badge) or via U.S. mail (Challenge Coin, Rivet) using the member’s contact information associated with the members h-d.com/hog account.

Participants should confirm that their correct email addresses are on file with Sponsor. Please allow 8 – 12 weeks for review of photo submissions and delivery of rewards.

Rewards are non-transferable, and no cash-outs will be provided. No substitutions of rewards unless determined in the sole discretion of the Sponsor. All taxes on rewards (if any) are the sole responsibility of participants.

PUBLICITY RELEASE: Except where prohibited, participation in the Challenge constitutes participant's consent that his or her name, likeness, voice and/or biographical data, including but not limited to photos submitted in connection with this Challenge, may be used for advertising and promotional purposes without limitation and without additional notice, compensation, or consent. Photos submitted may be available for viewing on the Internet by a world-wide audience.

PARTICIPANTS' AGREEMENT TO ABIDE BY RULES: By entering, participant agrees he/she has read, accepted and will abide by these Official Rules and agrees that any dispute with regard to the conduct of this Challenge, rule interpretation and application, the awarding of prizes, or any other matter related to the Challenge, shall be submitted to Sponsor, whose decision shall be binding and final.

RELEASE OF LIABILITY: By participating, participant agrees to release and hold harmless the Released Parties from any injury, loss or damage to person, including death, or property due in-whole or in-part, directly or indirectly, to the acceptance or use/misuse of any prizes, participation in any Challenge-related activity, or participation in the Challenge.

Released Parties are not responsible for any injury or damage to any person's computer or related equipment resulting from or relating to participation in this Challenge or downloading any material related to this Challenge. Sponsor and the other Releases assume no responsibility for Challenge' website, computer system, hardware, software or program malfunctions or other errors, failures, delayed computer transactions or network connections, whether human, technical or otherwise in nature.

Sponsor is prevented from continuing with this Challenge, Sponsor shall have the right, in its sole discretion, but not the obligation, to issue rewards to eligible photos received to date.
