On August 19, 2021, JLL Income Property Trust issued a press release announcing that on August 10, 2021 its Board of Directors approved a gross dividend for the third quarter of 2021 of \$0.135 per share. The dividend is payable on or around September 29, 2021 to stockholders of record as of September 24, 2021. All stockholders will receive \$0.135 per share less applicable share class specific fees and the annualized yield will differ based on the share class. Any future dividends will be made at the discretion of the board and will depend on the Company's earnings, financial condition, maintenance of its REIT status and such other factors as the board of directors may deem relevant from time to time.

Declares 39<sup>th</sup> Consecutive Quarterly Dividend**

**Chicago** (August 19, 2021) – JLL Income Property Trust, an institutionally managed daily NAV REIT (NASDAQ: [ZIPTAX](#); [ZIPTMX](#); [ZIPIAX](#); [ZIPIMX](#)) with more than \$4.5 billion in portfolio assets and 91 properties, announced that on August 10, 2021 its Board of Directors approved a gross dividend for the third quarter of 2021 of \$0.135 per share. JLL Income Property Trust has declared 39 consecutive quarterly dividends to its stockholders beginning with the first quarter 2012.

The dividend is payable on or around September 29, 2021 to stockholders of record as of September 24, 2021. On an annualized basis, this gross dividend is equivalent to \$0.54 per share and represents a yield of approximately 4.4 percent on a NAV per share of \$12.22 as of August 9, 2021. All stockholders will receive \$0.135 per share less applicable share class specific fees and the annualized yield will differ based on the share class.

“One of our primary investment objectives is generating reliable, durable current income for distribution to our stockholders,” said Allan Swaringen, President and CEO of JLL Income Property Trust. “We’ve now done that for nearly 10 years including throughout the economically depressed pandemic environment last year.” He continued, “In today’s yield-starved environment, core real estate has proven its benefits to long-term patient investors.”

A second quarter dividend of \$0.135 per share, less applicable share class specific fees, was paid according to the table below on June 29, 2021 to stockholders of record as of June 24, 2021. Any future dividends will be approved at the discretion of the Board of Directors.
