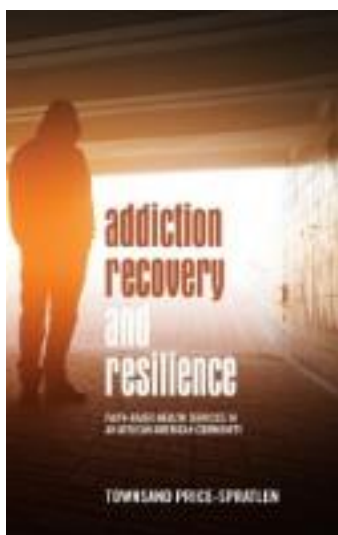

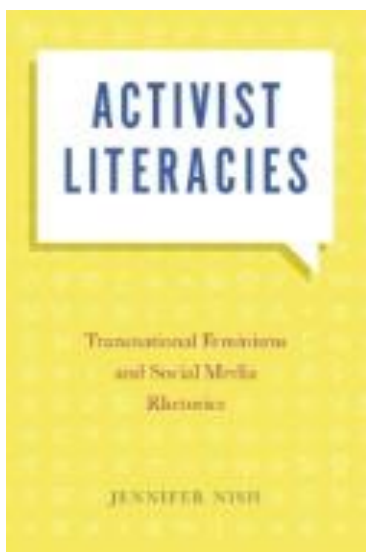

	<p>Ethical Case Studies for Advanced Practice Nurses : Solving Dilemmas in Everyday Practice</p> <p>Healthcare delivery can present ethical conflicts and dilemmas for advanced practice registered nurses (APRNs)—nurses who already have a myriad of responsibilities in caring for patients. Ethical Case Studies for Advanced Practice Nurses improves APRNs' agility to resolve ethical quandaries encountered in primary care, hospital-based, higher education, and administration beyond community settings. Through case studies examining various types of ethical conflicts, the authors empower APRNs and students with the critical knowledge and skills they need to handle even the most complex dilemmas in their practice. By applying a set of criteria and framework, this book guides APRNs to use critical thinking to make ethically sound decisions.</p>
	<p>Addressing Inaccurate and Misleading Information About Biological Threats Through Scientific Collaboration and Communication in Southeast Asia</p> <p>Misinformation about outbreaks, epidemics, and pandemics is a decades-old problem that has been exacerbated by the rise of the internet and the widespread use of social media. Some false claims may be addressed through sound scientific analysis, suggesting that scientists can help counter misinformation by providing evidence-based, scientifically defensible information that may discredit or refute these claims. This report explains how scientists can work collaboratively across scientific disciplines and sectors to identify and address inaccuracies that could fuel mis- and disinformation. Although the study focused on a scientific network primarily in Southeast Asia, it is relevant to scientists in other parts of the world. A companion 'how-to-guide', available in print and in digital form, outlines practical steps that scientists can take to assess mis- or disinformation, determine whether and how they should address it, and effectively communicate the corrective information they develop.</p>
	<p>Addressing Structural Racism, Bias, and Health Communication As Foundational Drivers of Obesity : Proceedings of a Workshop Series</p> <p>The National Academies of Sciences, Engineering, and Medicine's Roundtable on Obesity Solutions convened a three-part workshop series that explored how structural racism, weight bias and stigma, and health communication intersect with obesity, gaps in the evidence base, and challenges and opportunities for long-term, systems-wide strategies needed to reduce the incidence and prevalence of obesity. Through diverse examples across different levels and sectors of society, the workshops explored how to leverage the connections between these three drivers and innovative data-driven and policy approaches to inform actionable priorities for individuals, organizations, and policymakers to make lasting systems change.</p>



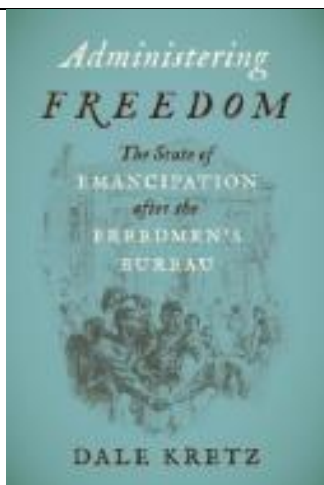
Addiction Recovery and Resilience : Faith-based Health Services in an African American Community

We live in an era of substance misuse colliding with public health shortcomings. Consequences of mass incarceration and other racial disparities of the 'drug war' are felt acutely in the neighborhoods and communities least equipped to deal with them. More than 600,000 people are released from US prisons each year; nearly two-thirds of returning citizens have a substance use disorder (SUD) and have limited access to treatment. Even among the general public, only one in ten people with SUD receive any type of specialty treatment. Community organizations make important contributions to improve access and help to heal these societal fractures. Using a social ecology of resilience model, *Addiction Recovery and Resilience* is a yearslong ethnographic case study of a faith-based health organization with a focus on long-term recovery. It explores the organization's triumphs and missteps as it has worked to respond to the opioid crisis and improve the health of affiliates and the neighborhood for nearly twenty years. *Addiction Recovery and Resilience* concludes with best practices for individual, organizational, and community health and public policy at a time when nontraditional health care providers are increasingly important.



Activist Literacies : Transnational Feminisms and Social Media Rhetorics

A groundbreaking rhetorical framework for the study of transnational digital activism What does it mean when we call a movement 'global'? How can we engage with digital activism without being 'slacktivists'? In *Activist Literacies*, Jennifer Nish responds to these questions and a larger problem in contemporary public discourse: many discussions and analyses of digital and transnational activism rely on inaccurate language and inadequate frameworks. Drawing on transnational feminist theory and rhetorical analysis, Nish formulates a robust set of tools for nuanced engagement with activist rhetorics. Nish applies her literacies of positionality, orientation, and circulation to case studies that highlight grassroots activism, well-resourced nonprofits, and a decentralized social media challenge; in so doing, she illustrates the complex power dynamics at work in each scenario and demonstrates how activist literacies can be used to understand and engage with efforts to contribute to social change. Written in an accessible, engaging style, *Activist Literacies* invites scholars, students, and activists to read activist rhetoric that engages with 'global' concerns and circulates transnationally via social media



Administering Freedom : The State of Emancipation After the Freedmen's Bureau

This book offers the definitive history of how formerly enslaved men and women pursued federal benefits from the Civil War to the New Deal and, in the process, transformed themselves from a stateless people into documented citizens. As claimants, Black southerners engaged an array of federal agencies. Their encounters with the more familiar Freedmen's Bureau and Pension Bureau are presented here in a striking new light, while their struggles with the long-forgotten Freedmen's Branch appear in this study for the very first time. Based on extensive archival research in rarely used collections, Dale Kretz uncovers surprising stories of political mobilization among tens of thousands of Black claimants for military bounties, back payments, and pensions, finding victories in an unlikely place: the federal bureaucracy. As newly freed, rights-bearing

citizens, they negotiated issues of slavery, identity, family, loyalty, dependency, and disability, all within an increasingly complex and rapidly expanding federal administrative state—at once a lifeline to countless Black families and a mainline to a new liberal order.



The 50 Greatest Explorers in History

This is a book about one of the first recorded pilgrims who climbed Mount Sinai; it's about Amelia Earhart, the famous American aviator whose story and disappearance continues to capture the world's imagination. It's the story of a doomed expedition to discover the North West Passage, and the tale of Marco Polo, who remained at the court of the Kublai Khan for an incredible 17 years. The 50 Greatest Explorers in History brings to life the pioneers in aviation flying thousands of miles with the most basic of maps in open cockpits, exposed to the elements and the unrelenting smell of petrol fumes. They travel by steamboat, on horseback, by rickshaw, motorbike, train, swim with piranhas, embark into black nothingness in new spacecraft, explore by Jeep, yachts, tea boats and elephants, disguise themselves as men, take canoes and use innovative, advanced technological scuba equipment. Going where in many cases, no man or woman had ever gone before, some women featured in this books were often denied respect, acknowledgment, or recognition and they determined to break the 'men's club' mentality of global exploration from which they were excluded.
