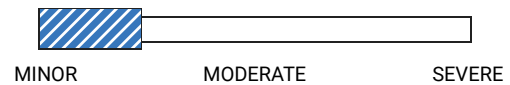

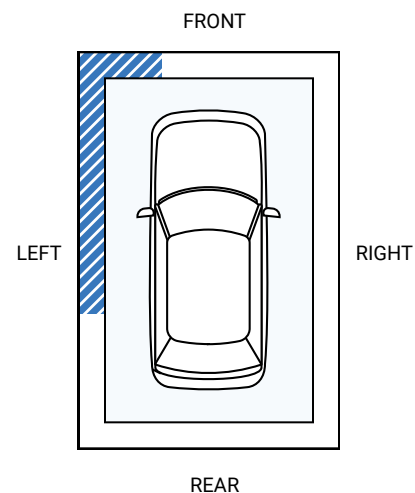

Glossary

Accident Indicator
