• 22/23 Debt Service Fund Budget

• FY 21/22 Revised Budget- General Fund

Chris Kipper gave an overview of the FY 21/22 Revised Budget-General Fund. After explanation Sarah Robbins called for a motion to approve the revised 21/22 General Fund Budget as presented. Motion made by Scott Shoenberger. Seconded by Kate Latts. All in Favor. *Motion Carried*.

• 2021-2022 Revised Budget- Debt Service Fund

Chris Kipper gave a summary of the Revised Debt Service Fund to the members. After explanation, Sarah Robbins called for a motion to approve the 21/22 Revised Budget-Debt Service Fund in the amount of in the amount of \$13,283,889. Motion made by **Guy Genoud**. Seconded by **Ryan Bridgeman**. **All in Favor**. <u>Motion Carried</u>.

COMMUNITY INVESTMENT COMMITTEE REPORT

Scott Shoenberger, Chair of CIC shared some highlights on 2 grants that were reviewed and approved at the last CIC meeting on March 11, 2022. Scott then made recommendations to Commission for final approval.

- Roots 101 African American Museum- Funding to be used for Sankofa \$25,000
- Waterfront Park Photography & Media- \$26,000

Sarah Robbins called for a motion for final approval of both grants totaling \$51,000. Motion was made by Scott Shoenberger. Seconded by Kate Latts. All in Favor. *Motion Carried*.

PRESIDENT'S REPORT

Cleo Battle shared just a few highlights of his President's Report due to the amount of time already spent on the FY22/23 budget approvals. Cleo reported that he was in Frankfort for the press conference regarding the announcement of the EDA Grant. Kentucky was awarded \$5.3 million for Kentucky Tourism and Louisville received \$1.3M of that money. The Governor said this is a drop in the bucket towards tourism. We need our Senate and House to make an amendment to include tourism in the budget. We feel good about where we are with the legislators, and we have our fingers crossed that they will come through in funding tourism. I also wanted to make the Commission aware that we made a change in marketing agency. We are moving from BCH to Doe-Anderson. We will be transitioning to them in quarter four. We are looking forward to partnering with them and seeing what they can do for Louisville Tourism.
