- 2025-2026 Proposed Goals & Fiscal Budget- General Fund Chairman Greene stated we have a motion from the Finance Committee to approve the 25/26 Goals & General Fund Budget and related budget certification resolution as presented. As the motion is from the Finance Committee, it does not require a second. There being no further discussion. All in Favor. <u>Motion Carried.</u>
- 2025-2026 Proposed Goals & Fiscal Budget Debt Service Fund Chairman Greene we have a motion from the Finance Committee to approve the 25/26 Proposed Goals & Fiscal Budget – Debt Service Fund Budget and the related budget certification resolution as presented. As the motion is from the Finance Committee it does not require a second. There being no further discussion. All in Favor. <u>Motion Carried.</u>

- TFN Chairman Greene we have a motion from the Finance Committee to approve an allocation up to \$200K per year for 4 years to secure or assist in the future siting or retention of multiple sports-related tourism and business events in Jefferson County, beginning in 2025. No further discussion. All in Favor. Motion Carried.
- US Travel ESTO Chairman Greene we have a motion from the Finance Committee to approve an allocation up to \$318,200 to secure and assist in the future siting or retention of a tourism industry conference in Jefferson County in September 2026. No further discussion. All in favor. <u>Motion Carried</u>.
- Connect Marketplace Spring Chairman Greene we have a motion from the Finance Committee to approve an allocation up to \$524K to secure or assist in the future siting or retention of a tourism industry conference in Jefferson County in April 2026. No further discussion. All in Favor. <u>Motion Carried</u>.
- International Thespian Festival Chairman Greene we have a motion from the Finance Committee to approve an allocation up to \$100K per year for 6 years to secure or assist in the future siting or retention of an arts and entertainment-related tourism and business event in Jefferson County, beginning in June 2027. No further discussion. All in Favor. Motion Carried.

COMMUNITY INVESTMENT COMMITTEE REPORT – George Stinson, Chair if the CIC Committee reported the following grant recommendations for board approval.

- Celebrate Lafayette's Return Dates: May 10-12, 2025 \$2400
- Destination Smooth Jazz Series- Dates: (4) dates in 2025 \$10,000
- Roots Revue Festival Dates: May 24-25, 2025 \$12,500
- Sky Soul Festival Dates: June 14, 2025 \$10,000
