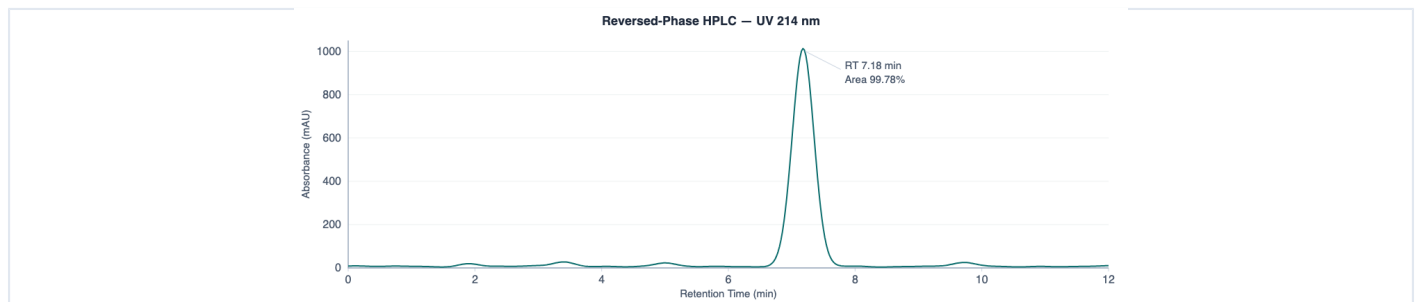

Notes & Methodology

- 1. Peptide identity confirmed by HPLC retention-time comparison against a reference standard.
- 2. Purity determined by RP-HPLC area normalization at 214 nm; the value is the target peptide as a percentage of all peptide-related peaks.
- 3. Elemental impurities (As, Cd, Cr, Hg, Pb) screened by ICP-MS.
- 4. Bacterial endotoxin measured by the LAL kinetic method.
- 5. Sterility assessed by a PCR-based screen.
