

## MARCUS THEATRES WICKED: FOR GOOD PROP REPLICA HAT SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN, NOR WILL A PURCHASE IMPROVE ONE'S CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

- 1. SPONSOR: Marcus Theatres Corporation, a Wisconsin corporation, having an address of 111 East Kilbourn Avenue, Suite 1200, Milwaukee, Wisconsin 53202 ("Sponsor").
- 2. PRIZE FULFILLER: Universal Pictures Marketing, a division of Universal Film Exchanges LLC having an address of 100 Universal City Plaza, Building 2160, Universal City, California, 91608 ("Universal" or "Prize Fulfiller").
- 3. ENTRY PERIOD: The Marcus Theatres Wicked: For Good Prop Replica Hat Sweepstakes (the "<u>Sweepstakes</u>") entry period begins October 8, 2025, at 12:00 AM Central Daylight Time and ends November 30, 2025, at 11:59 PM Central Standard Time ("<u>CST</u>") (the "<u>Entry Period</u>"). Sponsor's computer is the official time-keeping device for the Sweepstakes, including for determining whether an Entry (defined below) is received during the Entry Period. All Entries received after the end of the Entry Period will be disregarded and not included in the Sweepstakes.
- 4. METHOD OF ENTRY: Sponsor's Magical Movie Rewards members may enter the Sweepstakes by purchasing a ticket during the Entry Period for the feature movie, *Wicked: For Good*, for any show time at a participating Marcus Theatres or Movie Tavern location occurring between November 17, 2025, and November 30, 2025 (each, a "<u>Ticket Entry</u>"). A valid Magical Movie Rewards account number must be presented at the time of ticket purchase in order to receive a Ticket Entry. Any refund issued for a ticket that resulted in a Ticket Entry will cause such Ticket Entry to be void. Each participant is limited to one (1) Ticket Entry, regardless of the number of tickets purchased. Free registration as a Magical Movie Rewards member is available at https://www.marcustheatres.com/movie-rewards.

Alternatively, individuals may enter without making a purchase by mail as follows: on a 3" x 5" card, legibly handprint or type the participant's first name, last name, date of birth, phone number and email address and mail such card in an envelope to: Marcus Theatres, LLC, 111 East Kilbourn Avenue, Suite 1200, Milwaukee, Wisconsin, 53202, Attn: Advertising and Promotions Department – Marcus Theatres Wicked: For Good Prop Replica Hat Sweepstakes, as an Alternate Method of Entry (each a "Mail Entry"). All Mail Entries must be postmarked by December 1, 2025, and received by Sponsor by 5:00 P.M. CST on December 16, 2025. Ticket Entry and Mail Entry are referred to herein, collectively, as "Entry" or "Entries."

Limit one (1) Entry per person regardless of method of entry during the Entry Period (the "Entry Limit"). Entries that exceed the Entry Limit are void. Entries that are late (including due to delayed delivery or data transmissions), or are, in Sponsor's sole discretion, forged, illegible, mutilated, incomplete, misdirected, mechanically reproduced, irregular, or otherwise not in compliance with these Official Rules ("Official Rules") will be disqualified. The use of automated entry devices is prohibited and will result in disqualification. Proof of submitting an entry will not be deemed receipt of such entry by Sponsor.

5. ELIGIBILITY: The Sweepstakes is open only to legal residents of Arkansas, Colorado, Georgia, Illinois, Iowa, Kentucky, Louisiana, Minnesota, Missouri, Nebraska, New York, North Dakota, Ohio, Pennsylvania, Texas,

Virginia, or Wisconsin (the "Eligibility Area") who have reached their state of residence's age of majority at the time of entry. Void where prohibited or restricted by law. Employees, directors, officers, members, managers, agents, and representatives of (a) Sponsor; (b) Sponsor's parent, subsidiaries, and affiliated companies, including, without limitation, The Marcus Corporation; (c) Prize Fulfiller, and its parent, subsidiaries, and affiliated companies; or (d) any advertising, fulfillment, and promotional agencies affiliated with Sponsor (all of the entities listed in (b) and (d) collectively, the Sponsor's "Affiliates"), and the immediate family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win (each of the foregoing individuals and entities, a "Sweepstakes Party" and collectively, all of the foregoing are "Sweepstakes Parties"). The term "immediate family members" includes spouses, partners, parents, legal guardians, grandparents, siblings, children and grandchildren. The Sweepstakes is void outside of the Eligibility Area and where prohibited or restricted by law, and is subject to all federal, state, and local laws and regulations. Participation constitutes participant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning the Prize (defined below) is contingent upon fulfilling all requirements set forth in these Official Rules.

6. PRIZE: One (1) prop replica of Elphaba's hat. Total approximate retail value of Prize is \$00.00 USD (the "Prize").

Prize is a true-to-scale replica and, as such, was NOT actually used by talent in the film *Wicked: For Good* (the "Film"). Transfer of Prize is not permitted without the permission of Sponsor which may be granted or withheld in its sole discretion and without liability of any kind. Prize will not be accompanied by a certificate of authenticity. Prize has not been autographed by any actor, director, producer or other professional involved with the Film.

Approximate Retail Value ("ARV"), as stated above, represents Sponsor's good faith determination of the ARV of the Prize. Exact item(s) of the Prize will be determined by Prize Fulfiller in their sole discretion. No additional retail value is associated with collectible items. Any difference between the ARV stated above and the actual value of the Prize will not be awarded. Odds of winning depend on total number of eligible Entries received. All incidental expenses, including, but not limited other personal expenses, costs, and taxes not specified herein will be the sole responsibility of the winner, including without limitation, federal and state taxes. In the event the Prize is valued at \$600 or more, Sponsor will issue an IRS Form 1099 reflecting the actual value of the Prize won. However, winner's failure to receive an IRS Form 1099 does not relieve winner of applicable tax requirements.

No substitution, exchange or cash redemption of a Prize is permitted, provided that only if the Prize cannot be awarded due to circumstances beyond the control of Sponsor or Prize Fulfiller, a substitute prize of equal or greater value will be awarded. The Prize is subject to change and may be withdrawn at any time. Transfer of a Prize is not permitted without the written consent of Sponsor, which may be granted or withheld at Sponsor's sole discretion, for any reason, and without liability of any kind.

- 7. PRIZE DRAWING: Sponsor will select one (1) potential winner in a random drawing on or about December 17, 2025, from among all eligible entries received.
- 8. WINNER: The winner will be notified on or about December 18, 2025, by the email address or phone number provided in their Entry. Sponsor is not responsible if a prize notification is not received for any reason. Any portion of a Prize not accepted by a winner will be forfeited. Disqualification and the selection of an alternate winner will result from any of the following: (1) potential winner's inability to accept a Prize; (2) potential winner's failure to execute and return an Affidavit of Eligibility/Release of Liability/Publicity Release by the deadline stated by Sponsor in the prize notification; (3) the return of a prize notification as undeliverable; or (4) any other noncompliance with these Official Rules. If Sponsor is unable to confirm any winner, at Sponsor's option, the Prize may go un-awarded. they will abide by and be bound by these Official Rules in full and without condition; (2) the Entry becomes solely the Sponsor's property and will not be acknowledged or returned; (3) no Sweepstakes Party is responsible for claims, injuries, death, losses or damages of any kind resulting from Sweepstakes participation or inability to participate; the awarding, acceptance, use, misuse, possession, loss or misdirection of a Prize or parts thereof; or participation in any Prize related activity: (4) winner's acceptance of the Prize constitutes the grant of an unconditional right to Sponsor and its Affiliates to use winner's first name and last initial, address (city and state only), and Prize information and/or statements about the promotion for any publicity, advertising and promotional purposes, including the right to print, publish, and use, worldwide in any media now known or hereafter developed. including without limitation, the World Wide Web, without additional compensation or limitation, except where prohibited by law; (5) any portion of a Prize not accepted by the winner will be forfeited; (6) Sponsor is not responsible for any inability of a winner to accept a Prize, or any part thereof, for any reason; (7) in the event that any dispute arises regarding the meaning or interpretation of these Official Rules, the dispute shall be resolved by applying the internal laws of Wisconsin, without regard to conflicts of law provisions, by and within the courts of that state within one (1) year of the Prize being awarded; PARTICIPANTS WAIVE ALL RIGHTS TO BRING OR PARTICIPATE AS A PARTY IN A CLASS ACTION LAWSUIT WITH REGARD TO THE SWEEPSTAKES AND ANY PRIZE AWARDED HEREUNDER; (8) by entering this Sweepstakes, all participants agree that Sponsor has the sole right to decide all matters relating to the Sweepstakes, including fact, interpretation, eligibility, procedure, fulfillment, and disputes from the Sweepstakes, these Official Rules, and its determination of the qualifiers and winner is final and binding. In the event a question arises regarding a winner's identity, Entry will be deemed made by the holder of the email account associated with the Entry. Entries are void if unreadable, inaccurate, incomplete, mutilated, tampered with, forged, mechanically reproduced, postage due, misdirected, late, irregular in any way, or otherwise not in compliance with these Official Rules.

Although Sponsor attempts to ensure the integrity of the Sweepstakes, none of the Sweepstakes Parties are responsible for the actions of participants or other individuals in connection with the Sweepstakes, including attempts by participants or other individuals to circumvent these Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. If, for any reason, Sponsor is not capable of running the Sweepstakes or if Prize Fulfiller is unable to supply a Prize or any part thereof, by reason of damage by computer virus, worms, bugs, tampering, unauthorized intervention, fraud, technical limitations or failures, strikes, industry conditions, bankruptcy or liquidation, marketplace demands, applicable law, unforeseen obstacles, or any other causes which, in the sole opinion of Sponsor, could corrupt, compromise, undermine, or otherwise affect the administration, security, fairness, integrity, viability, or proper conduct of the Sweepstakes, Sponsor reserves the right in its sole and absolute discretion to modify these Official Rules, and/or to cancel, terminate, modify or suspend all or any part of the Sweepstakes, and in the event of cancellation or termination, to select winner from among all eligible non-suspect Entries received up to the time of such cancellation, termination, modification, or suspension, as applicable. None of the Sweepstakes Parties will be liable to any person in connection with any action taken pursuant to the forgoing sentence. Inclusion in such drawing will be each participant's sole and exclusive remedy under such circumstances.

IN NO EVENT WILL ANY SWEEPSTAKES PARTY BE RESPONSIBLE OR LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND, INCLUDING WITHOUT LIMITATION, DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES, ARISING OUT OF ANY ACCESS TO AND/OR USE OF THE SPONSOR'S THEATRES, OR DISCONTINUATION OF ACCESS TO, ANY MATERIALS, OR THE ACCEPTANCE, POSSESSION, USE OR MISUSE OF, OR PARTICIPATION IN, ANY PRIZE AWARDED IN CONNECTION WITH THE SWEEPSTAKES. - A. Prize Fulfiller and its parent, affiliates, and subsidiaries are not a sponsor of this Sweepstakes, and are not responsible for the collection, submission or processing of Entries, and the administration of the Sweepstakes, or the selection of the winner. Entrants are supplying their information directly to Sponsor and not to Prize Fulfiller. By entering this Sweepstakes, participant agrees that Sponsor may share participant's personal information with its Affiliates and/or another Sweepstakes Party for the purpose of prize fulfillment in the event participant is chosen as a potential winner. Additionally, if a participant chooses to opt-in to a specific offer from a participating Sweepstakes Party, participant's personal information will be subject to that Sweepstakes Party's privacy policy and terms of service (if applicable) and such participant agrees to receive email communication from that Sweepstakes Party. LAW: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of any participant or Sponsor in connection with the Promotion shall be governed by and construed in accordance with the internal laws of the State of Wisconsin without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws.
