You are invited to submit bids to the Canyons School District relating to CARPET WARP AND YARNS. The bid will be awarded to the lowest responsive bidder. Responsiveness to the bid will be established only if the bid meets the following requirements:

Vendors must respond in each and every area as specified in the bid documents, such as packaging, pricing, etc. When more than one pricing request is made, each must be completed, and the bid must be returned in its entirety. If bidder's package count differs from the requested package count, it is the responsibility of the bidder to convert their unit price to reflect the requested package count and to note on the line item being bid the bidder's actual package count. Failure to do so may result in disqualification.

PRICES: All prices must be FOB destination, Freight Prepaid and Allowed, unless otherwise indicated to: 225 E. 9300 South, Sandy, Utah 84070. Prices shall NOT include tax. All prices should be rounded to the nearest cent.

Any early payment discounts offered to the Canyons School District are encouraged. Discounts shown may be evaluated as part of the bid award. Discounts offered for fewer than 10 working days will not be acceptable.

GENERAL INSTRUCTIONS

This agreement shall commence on the date of bid acceptance by the Board and continue for one (1) year. After 120 days/four months, one manufacturer's increase may be negotiated by the distributor with written verification from the manufacturer not to exceed five percent (5%). Any decreases will also be passed on to Canyons School District.

SAMPLE: A sample is requested for each product not listed as an "acceptable brand". Each sample will be tested to determine if it meets the specifications. A bid is non-responsive if the sample evaluation fails to meet these specifications.

Any manufacturer's name, trade name, brand name or catalog number used in these specifications are for illustrative purposes to provide a model describing general performance and quality levels only. Such references are not intended to be restrictive, and quotes are invited on these and comparable brands or products by any manufacturer. Any specification provided with use of manufacturer's name, trade name, brand name or catalog number shall control and take precedence over such manufacturer information. However, in the absence of a specification, the manufacturer's name, trade name, brand name or catalog number shall establish the general performance and quality levels acceptable to the District. All items will be evaluated on an "acceptable substitute" basis unless stated otherwise.

Quantities shown are estimates only. The district reserves the right to order any quantities on an as needed basis.

New purchase orders may be created for additional orders throughout the contract year.

Vendors will be required to attach a Material Safety Data Sheet (MSDS) on each item. The MSDS Sheet must accompany the bid and show manufacturer's name, address, telephone, fax, and composition of materials. It should also include trade name, hazardous ingredients, physical data, fire and explosion data, reactivity data, and list any other information as required by law. In the event that the product specifications change during the duration of the contract, a current MSDS Sheet must be furnished immediately to the District.

Central Warehouse Shipping And Delivery: Vendor shall notify Canyons School District twenty-four (24) hours prior to time of delivery by contacting Randy Gray, Warehouseman, at (801) 567-8836, to arrange for receiving. All arrangements and deliveries are to be made Monday through Friday, between 8:00 a.m. and 12:00 p.m., and 1:00 p.m. and 3:00 p.m. (Mountain Time). Where applicable, all products must arrive at the warehouse on pallets and stretch wrapped. Pallet size to be four (4) way, 40" W x 48" L. Exchange of pallets available upon delivery.
