



# Tips On Selling To The Government

- **KNOW WHAT YOU HAVE TO SELL.** Government agencies are interested in knowing what you have done. You will need to be able to show that you have a track record in selling your product or service.
- TARGET YOUR MARKET. There are many government agencies in Idaho including federal agencies, military bases, county governments, city governments, transportation agencies, public schools, and universities. You will need to sift through all of these agencies to find the agencies that buy a significant amount of what you sell.
- EDUCATE YOURSELF. Learn the government's procurement processes. From the acronyms to the regulations to the procedures.

  Hint: Contact the agency procurement professional and ask to meet with him/her to discuss procurement procedures with that agency.
- **ASSESS YOUR COMPETITION.** Once you have targeted your market, you can find out how competitive it has been. A good place to start is a review of the current contract. Many times, this is available just by asking. If not, a public records request with the agency can provide the document.
- MARKET AGGRESSIVELY. Once you find a good potential customer, you should market to him or her the same way you would a private sector customer. You can do this in two ways:
  - » By ensuring that they are aware of your capabilities.
  - » By staying in touch. Many of the smaller contracts do not have to be formally bid and you can put yourself in a good position to get business by being persistent.
- MAKE SURE YOU COMPLETE THAT FIRST CONTRACT SUCCESSFULLY. After you win that first contract, your potential for winning others depends on whether you can show that you can do the job in a quality fashion. If you do a great job, it increases your chances of getting more contracts because you are now a known entity. The reverse is also true.
  - **Consider Joining Cooperative Contracts.** Many agencies across Idaho have been utilizing various cooperative contracts since the Idaho statute was updated in 2019 to allow for additional types of cooperatives. This is a great purchasing vehicle especially for those companies that have products agencies consistently need.

Hint: Make sure to check with each agency to see what cooperative contracts they are allowed to use.

- Be open, fair, impartial, and non-discriminatory in all processes.
- Treat suppliers equitably, without discrimination, and without imposing unnecessary constraints on the competitive market.
- Use sound professional judgment within established legal frameworks to balance competing interests among stakeholders.

**Professionalism:** Upholding high standards of job performance and ethical behavior... essential to balance diverse public interests.

- Continually contribute value to the organization.
