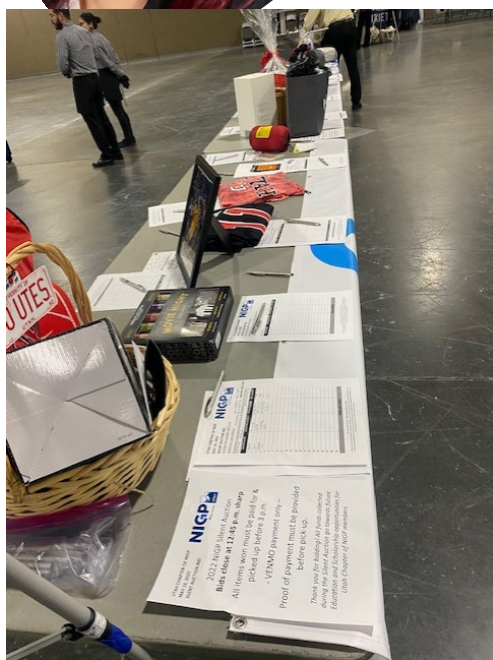
THE UTAH CHAPTER OF NIGP IS EXCITED TO SHARE ITS EFFORTS TO FOSTER STRONG RELATIONSHIPS BETWEEN PUBLIC AGENCIES AND VENDORS THROUGH ITS REVERSE TRADE SHOW PROGRAM AND ITS INNOVATIVE IDEA TO HOST A SILENT AUCTION FUNDRAISER. THIS WAS THE 2ND YEAR THE UTAH CHAPTER HOSTED A REVERSE TRADE SHOW AND OUR LARGEST FUNDRAISER OF THE YEAR WITH REVENUE OF \$99,640, MINUS EXPENSES OF \$44,263.57 = TOTAL REVENUE OF \$55,376.61 AND AN ADDITIONAL \$2600 FROM SILENT AUCTION DONATIONS FROM MEMBERS AND VENDORS.

ADDITIONALLY, IN DECEMBER 2022, THE UTAH CHAPTER PUBLISHED AN ANNUAL REPORT HIGHLIGHTING THE CHAPTER'S MEMBERSHIP RECORDS, MEMBERSHIP BENEFITS, PROCUREMENT DECLARATION, ACHIEVEMENTS, ACCOMPLISHMENTS, SOCIAL EVENTS, AREA 9 CONFERENCE, LISTING 71 NEW CHAPTER MEMBERS, MEMBER CERTIFICATIONS, CHAPTER AWARDS, AND END-OF-YEAR HIGHLIGHTS.

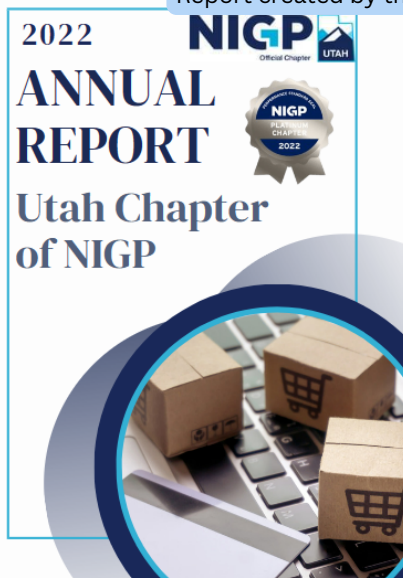

PROGRAM DESCRIPTION [2 PROGRAMS HIGHLIGHTED]:



THE REVERSE TRADE SHOW:

THE REVERSE TRADE SHOW IS AN EVENT THAT BRINGS TOGETHER PROCUREMENT PROFESSIONALS FROM PUBLIC AGENCIES AND VENDORS IN A REVERSE TRADE SHOW FORMAT. THE IDEA IS TO CREATE A PLATFORM WHERE VENDORS MEET WITH PUBLIC PROCUREMENT PROFESSIONALS.

THE EVENT BEGAN WITH A KEYNOTE SPEAKER, FRANK KITCHEN, WHO BROUGHT A "FRESH" PERSPECTIVE ON LIFE AND LEADERSHIP. FOLLOWED BY A NETWORKING SESSION WHERE VENDORS AND PROCUREMENT PROFESSIONALS MINGLED AND EXCHANGED BUSINESS CARDS. AFTER THE NETWORKING SESSION, THE ACTUAL TRADE SHOW BEGAN. AGENCIES WERE PROVIDED WITH A TABLE AND VENDORS THEN WALK AROUND VISITING AGENCIES THEY WERE INTERESTED IN WORKING WITH.

ONE OF THE NEW AND UNIQUE FEATURES OF THE REVERSE TRADE SHOW IS THIS YEAR WE HELD A SILENT AUCTION AS AN ADDITIONAL FUNDRAISER EVENT. WE ASKED AGENCIES AND VENDORS TO DONATE ITEMS TO THE AUCTION AND ALL THE MONEY RAISED WHEN BACK TO THE UTAH CHAPTER COMMUNITY TO SUPPORT OUR EFFORTS IN PROVIDING SCHOLARSHIPS AND HOSTING IN-PERSON MEETINGS. OVERALL 54 ITEMS WERE DONATED BRINGING IN AN ADDITIONAL \$2600 TO HELP THE UTAH CHAPTER PROVIDE SCHOLARSHIPS TO CHAPTER MEMBERS.

THE REVERSE TRADE SHOW AND THE UTAH CHAPTER OF NIGP END OF YEAR REPORT AND AWARD RECOGNITION PROGRAMS HAVE BOTH BEEN HUGE SUCCESSFUL IN THEIR RESPECTIVE WAYS.



THE REVERSE TRADE SHOW:

THE REVERSE TRADE SHOW ALLOWED PUBLIC AGENCIES AND VENDORS TO COME TOGETHER AND BUILD RELATIONSHIPS, LEADING TO INCREASED COLLABORATION AND BETTER PROCUREMENT OUTCOMES. OUR CHAPTER SAW AN INCREASE IN ATTENDANCE FROM BOTH PUBLIC AGENCIES AND VENDORS AT THE REVERSE TRADE SHOW, AND MANY VALUABLE RELATIONSHIPS WERE FORMED AS A RESULT.

ATTENDEE FEEDBACK FOR THE MAIN EVENT AND BREAKOUT SESSIONS WAS OVERWHELMINGLY POSITIVE. MANY ATTENDEES ALSO COMMENTED ON THE HIGH LEVEL OF ORGANIZATION AND COORDINATION THAT WENT INTO THE EVENT, NOTING THAT IT WAS CLEAR THAT A LOT OF EFFORT HAD BEEN PUT INTO ENSURING THAT THE EVENT RAN SMOOTHLY AND WAS VALUABLE FOR ATTENDEES. THE SILENT AUCTION WAS ALSO VERY POPULAR AND HELPED TO KEEP ATTENDEES ENGAGED AND INTERESTED THROUGHOUT THE ENTIRE EVENT BECAUSE YOU HAD TO BE PRESENT TO WIN AN ITEM YOU BID ON.

OVERALL, BOTH PROGRAMS HAVE HAD A POSITIVE IMPACT ON OUR CHAPTER'S SUCCESS, AND WE ARE PROUD TO HAVE IMPLEMENTED THEM.

THE REVERSE TRADE SHOW:

THE REVERSE TRADE SHOW SILENT AUCTION WAS A UNIQUE AND INNOVATIVE ADDITION TO OUR REVERSE TRADE SHOW PROGRAM. THIS EVENT ALLOWED US TO SHOWCASE THE GENEROUS SPIRIT OF OUR MEMBERS AND VENDORS AND RAISED MONEY FOR OUR SCHOLARSHIP FUND, ALL WHILE BUILDING RELATIONSHIPS AND FOSTERING COLLABORATION. WE RECEIVED A TOTAL OF 54 DONATIONS FOR THE AUCTION, WITH HALF COMING FROM PUBLIC AGENCIES OR THEIR EMPLOYEES AND A HALF FROM THE VENDOR COMMUNITY. THE AUCTION GENERATED AROUND \$2600, WITH VENDOR DONATIONS BRINGING IN APPROXIMATELY \$1900 AND PUBLIC AGENCY DONATIONS RAISING AROUND \$700. THE DIVERSE RANGE OF DONATIONS INCLUDED UNIQUE ITEMS SUCH AS TICKETS TO UTAH JAZZ BASKETBALL GAMES, TICKETS TO THE UNIVERSITY OF UTAH FOOTBALL GAMES, AND AN ELECTRICAL HEIGHT-ADJUSTABLE DESK AND OFFICE ACCESSORIES FROM SKINNER GROUP. ADDITIONALLY, NIGP ALSO MADE A GENEROUS DONATION BY PROVIDING FREE VIRTUAL REGISTRATION TO THE 2022 NIGP FORUM. THE SILENT AUCTION WAS A GREAT WAY TO BRING THE PROCUREMENT COMMUNITY TOGETHER, SHOWCASE THE GENEROSITY OF OUR MEMBERS AND VENDORS, AND RAISE FUNDS FOR OUR SCHOLARSHIP PROGRAM. WE BELIEVE THAT THIS INNOVATIVE ADDITION TO OUR REVERSE TRADE SHOW PROGRAM IS SOMETHING OTHER CHAPTERS COULD EMULATE TO ADD A UNIQUE AND ENGAGING FUNDRAISING ELEMENT TO THEIR EVENTS.

SOME LESSONS LEARNED WHILE HOSTING SUCH AN EVENT INCLUDE THE IMPORTANCE OF PROPER PLANNING, EFFECTIVE COMMUNICATION, AND CLEAR EXPECTATIONS FOR BOTH VENDORS AND ATTENDEES. IT'S ESSENTIAL TO ENSURE THAT VENDORS HAVE AMPLE TIME TO REGISTER, WHILE ATTENDEES UNDERSTAND THE EVENT'S PURPOSE AND WHAT THEY CAN EXPECT TO GAIN FROM ATTENDING. IT'S ALSO CRUCIAL TO PROVIDE A COMFORTABLE AND INVITING ATMOSPHERE FOR EVERYONE INVOLVED, AS THIS CAN ENHANCE THE OVERALL EXPERIENCE AND CREATE A POSITIVE IMPRESSION FOR FUTURE EVENTS. LASTLY, GATHERING FEEDBACK FROM BOTH VENDORS AND ATTENDEES CAN HELP IMPROVE FUTURE EVENTS AND ENSURE CONTINUED SUCCESS.

SELECTING INDIVIDUALS FOR RECOGNITION SHOULD BE BASED ON OBJECTIVE CRITERIA THAT ALIGN WITH THE ORGANIZATION'S GOALS AND VALUES. IT'S ALSO IMPORTANT TO PROVIDE AMPLE OPPORTUNITIES FOR FEEDBACK AND INPUT FROM ALL BOARD MEMBERS TO ENSURE THAT THE RECOGNITION AND AWARDS PROCESS IS FAIR AND TRANSPARENT. FINALLY, IT'S ESSENTIAL TO CREATE A MEMORABLE AND ENJOYABLE AWARD CEREMONY THAT CELEBRATES THE ORGANIZATION'S SUCCESSES AND MOTIVATES MEMBERS TO CONTINUE WORKING TOWARDS ITS GOALS.

WHY UTAH SHOULD BE SELECTED FOR THE ADVOCACY AND OUTREACH AWARD:

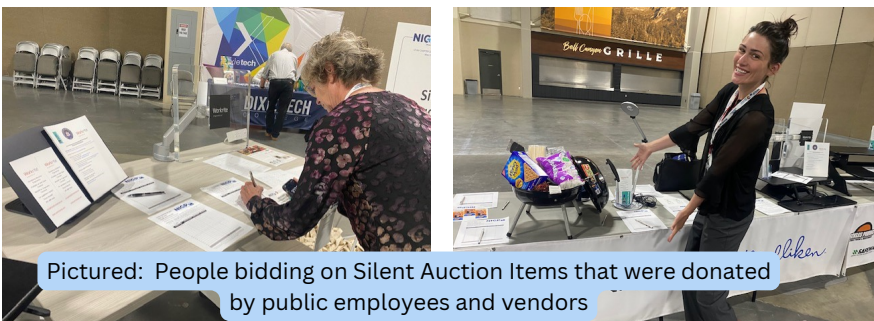

WE BELIEVE THAT OTHER CHAPTERS CAN FOLLOW UTAH'S EXAMPLE BY CREATING SIMILAR RECOGNITION PROGRAMS THAT ACKNOWLEDGE THEIR MEMBERS' SUCCESSES AND CONTRIBUTIONS TO THE PROCUREMENT PROFESSION. BY DOING SO, THEY CAN ALSO MOTIVATE THEIR MEMBERS TO CONTINUE TO STRIVE FOR EXCELLENCE AND BUILD A STRONGER PROCUREMENT COMMUNITY.
