What It Is

A program to provide outreach and communication to the membership of VAGP through the use of 9 geographical Zones within the commonwealth. Ambassador Expectations

Ambassadors are a vital component in support of VAGP's mission to promote professionalism in public procurement. In order to maintain a successful program, we ask that every Ambassador meet the following expectations:

- Issue a monthly or bi-monthly newsletter to their assigned zone highlighting local opportunities for networking, education, and career enhancement activities. (this should not be a forward of existing VAGP/NIGP emails that we already receive)
- Obtain quarterly membership updates and forward any bounced emails to the membership committee for follow-up
- Routinely check with your zone on opportunities to host a class or if they have a specific need that you might be able to facilitate getting a host for them.

- Reach out to non-VAGP members to see if they would like to become a member and keep the membership chair in the loop
- Consider hosting networking events
