ANNOUNCEMENTS - AUDIT 2021



Summary remarks of NIGP Central Florida Chapter's financial records review for the year ending December 31, 2021.

A summary review of the financial records and bank statements were conducted to determine if adequate financial controls are in place, identify any findings/issues and to provide recommendations. Neither serious material issues nor findings were found in this annual review. Although I reviewed the majority of the records, audits are not a complete review of every record. Sampling was used in many areas. Most files contain all the necessary documentation to conduct this review. I was able to spot check many income deposits/debits (cash and checks) entries, stripe payments/transfers and bank statements. The back up support documents are in excellent order. The following are comments in regards to this review:

- Explanation of unusual items. Three years of invoices were paid for one particular vendor. The support documentation included all the invoices but did not include a reason why three years was paid (two being past due). Unusual transactions should have more thorough explanations attached to the support documents.
- Some of the deposit explanations were brief. For example, a NIGP rebate was listed for one deposit on the CFC NIGP QuickBooks Deposit Form. However, why the chapter received the rebate was not detailed. Include concise explanations of rebates.
- Officers who approve reimbursements should not approve their own reimbursement. An alternative officer should serve as the second approver.
- All reimbursements had supporting documents that the expense was paid.
 However, it did not show who paid the expense. This situation could be
 manipulated by a chapter member who has their agency pay for an expense than
 gets reimbursement from the chapter. Evidence of who has made the payment
 should also be attached along with evidence that the expense was paid.



LEGISLATIVE UPDATES

Legislative Session Wraps Filed By: Juliet Misconi, MPA, NIGP-CPP, CPPO, CPPB CFCNIGP Legislative Task Force Chair

The Legislative Session ended up on March 11, 2022. Four bills related to Procurement passed both the House and Senate ("ordered enrolled"), but at the time of this writing (mid-April), they have not yet presented them to the Governor for consideration and signature. Because the Legislative Session starts earlier in even years, this timeframe is typical. The Task Force has prepared a spreadsheet of these bills and posted it to the Chapter's website under Documents & Files/Legislative Updates. I strongly encourage you to review the brief synopsis and, if this impacts your agency, read the bills in their entirety and read the Staff Analysis from myfloridahouse.gov or fisenate.gov. Type in the Bill Number in the search bar at the top to get to the bill page. You can navigate the bills from either site. The "enrolled" version of the Bill Text (or "er" on the Senate site) is the final version they will present to the Governor. There are staff analyses from various committees on both sites; choose the most recent to read their breakdowns of the impact of the bills. HB 7049, Legal Notices, may affect your agency if your agency chooses to post legal notices (agency wide) on your website instead of a newspaper. Most of the other bills have little effect on daily operations but are interesting and worth noting.

HB 375 Professional Structural Engineers


CERTIFICATION SUPPORT







Once you have completed you have to start looking ahead to re-certify in five years. It comes around quicker than you think it will. The continuing credit hours we earn from conferences, workshops and symposiums that we participate in during the years is the main source of the credits. Keeping track until you re-certify and then getting them all together can take a long time when you are sitting down to put the application together.

Tip # 1

Biggest tip is that UPPCC recertification can be started the day after receiving your CPPB or CPPO certification or recertification. You are able to go into your account and begin the re-certification process immediately. Get your basic information in and then as you receive each certificate you can upload right into the site for safe keeping. We all need less stress and when it is time to submit, your documents will be there waiting for you.
