Registration Form Instructions

- Print or type and complete all sections of the registration form.
- Retain a copy for your records.
- For in-person registrations, August 12, 2026 is the last day to receive advance registrations. Registrations received after **August 12, 2026** will be processed on-site at the Greater Columbus Convention Center and billed at the late registration rate. Registration for the virtual experience will remain open until **August 26, 2026**.

Payment

- Acceptable forms of payment are credit card, check or purchase order. NIGP accepts Visa, MasterCard or American Express.
- When paying by credit card include your billing address and card security code on the form and fax OR mail to the address on the form.
- If paying by check, make checks payable to NIGP and mail to the address on the form.
- When paying by purchase order, a copy of the purchase order must accompany your registration to be processed.
- Purchase Orders are not recognized as payment and full payment must be made by one of the payment options listed above.
- All fees are charged in US Dollars.

Methods of Registration

Email

Fax

- Complete the registration form, include payment information and fax it to 703-635-2326.

Mail

Internet

On site

- Registrations received after **August 12, 2026**, will be processed on-site at the Greater Columbus Convention Center. On site registrations will be billed at the late registration rate.

Confirmation

All registrants will receive an email confirmation that includes payment and balance information upon receipt and processing of their registration.

Cancellations and Refunds

- All cancellations must be submitted in writing to forum@nigp.org.
- Cancellations received **on or before July 23, 2026**, will be refunded in full, less a **\$175 administrative processing fee**.
- If you cancel **after July 23, 2026**, **no refunds** will be issued. However, if you registered for the **in-person event**, you can switch to the **virtual forum** instead. Please note that this transfer **does not include a refund**.
