# Introduction

NIGP: The Institute for Public Procurement, in collaboration with NIGP Consulting, commissioned Dr. Mohamad Alkadry in January 2024 to conduct a benchmark survey of public procurement entities in the United States and Canada to collect data on common practices in the field of public sector procurement. Working with NIGP Consulting leadership and committees of public procurement professionals across North America, the research team prepared a survey instrument (see Appendix 1). The survey included two parts: part one focused on higher level procurement topics, and part two focused on a deeper dive into specific topics. After completing part one, respondents were given the option to complete the second part.

The benchmark survey was sent to all NIGP designated agency representatives (2556) on March 5, 2024. Subsequent reminders to complete the survey were sent on March 11, March 14, and March 18. Responses were anonymous, though the system only sent reminders to agency representatives who had not already completed the survey. As a result of these three reminders and the original email, a total of 622 surveys were completed during this phase of the study. Subsequent to the initial collection of responses, NIGP Consulting leadership shared the survey on social media and invited non-NIGP members as well as encouraging NIGP members to complete the survey. The invitation went through an anonymous link and a total of 165 responses were collected through this link.

All data collection ended by the first week of May when the results were downloaded. The data cleaning process involved removing multiple responses from the same organization and replaced text values with numeric values for open-ended questions. The final dataset included 751 responses with no duplicates. Of the 751 respondents, 298 respondents completed the second part of the survey. It is also important to note that not all respondents answered all questions. Therefore, the number of responses varies by question.

This report is a summary of responses received and treats the entire population of respondents as one group. However, NIGP Consulting has access to additional data which will allow that team to produce benchmark data that compares an organization to its peers. The three tables that follow demonstrate the level and detail of data available through this survey. Sample Table i shows the type and level of data available in this report. Sample Tables ii and iii provide examples of the level of detail and benchmark analysis across entities available through NIGP Consulting. All three sample tables focus on the degree of centralization of the procurement function in the entities that responded to the survey.
