

Change-of-Name Agreement

Allsteel Inc. (Contractor), a corporation duly organized and existing under the laws of Illinois with its principal office in Muscatine, Iowa, and the United States of America (Government), enter into this Agreement as of December 31, 2022.

(a) The parties agree to the following facts:

(1) The Government, represented by various Contracting Officers, has entered into certain contracts and purchase orders with the Contractor as shown in the attached list marked "Exhibit A" and incorporated in this Agreement by reference. The term "the Contracts," as used in this Agreement, means the contracts shown on Exhibit A and all other contracts and purchase orders, including all modifications, made by the Government and the Contractor before the effective date of this Agreement (whether or not performance and payment have been completed and releases executed if the Government or the Contractor has any remaining rights, duties, or obligations under these contracts and purchase orders).

(2) Allsteel Inc., by Statement of Conversion filed with the Illinois Secretary of State on December 20, 2022, with an effective date of December 31, 2022, has converted from a corporation to a limited liability company and changed its name to Allsteel LLC accordingly.

(3) This Statement of Conversion accomplishes a conversion from a corporation to a limited liability company and a change of name only, and all rights and obligations of the Government and the Contractor under the Contracts are unaffected by this change.

(4) Documentary evidence of this conversion and change of name has been filed with the Government and is attached as "Exhibit B".

(b) In consideration of these facts, the parties agree that -

(1) The Contracts covered by this Agreement are amended by substituting the name "Allsteel LLC" for the name "Allsteel Inc." wherever it appears in the contracts; and

(2) Each party has executed this Agreement as of the day and year first above written.

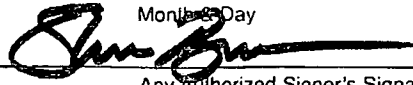
