Thereafter, Amendment Three (3) to align price adjustments with current products was executed on April 22, 2024.

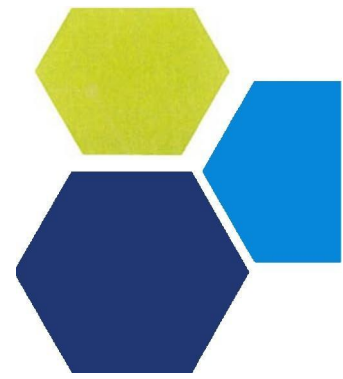
Thereafter, Amendment Four (4) to extend the contract period from May 15, 2025 to May 14, 2026 was executed on April 22, 2025.
