

AMENDMENT NO. 01 TO MASTER AGREEMENT CONTRACT NO. 264789, L-336(5)

THIS AMENDMENT is by and between the State of Minnesota, acting through its Commissioner of Administration (“State”), in cooperation with NASPO ValuePoint and Federal Signal Corporation, 1333 Butterfield Road, Suite 500, Downers Grove, IL 60515 (“Contractor”).

WHEREAS, the State has a Contract with the Contractor identified as Master Agreement Contract No. 264789, March 13, 2025, through February 28, 2027 (“Contract”), to provide Public Safety Vehicle Lights, Sirens and Accessories; and

WHEREAS, Minn. Stat. § 16C.03, subd. 5, affords the Commissioner of Administration, or delegate pursuant to Minn. Stat. § 16C.03, subd. 16, the authority to amend contracts; and

WHEREAS, the terms of the Contract allow the State to amend the Contract as specified herein, upon the mutual agreement of the Office of State Procurement and the Contractor in a fully executed amendment to the Contract.

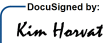
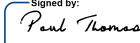
NOW, THEREFORE, it is agreed by the parties to amend the Contract as follows:

1. Within Attachment C- Pricing, *Section 1: Authorized Distributor List* (page 33 of 265) is REPLACED with *Section 1: Authorized Distributor List, Version 2*, attached herein.
2. All other pricing, terms and conditions remain the same.

This Amendment is effective beginning October 29, 2025, or upon the date that the final required signatures are obtained, whichever occurs later, and shall remain in effect through contract expiration, or until the Contract is canceled, whichever occurs first.

Except as herein amended, the provisions of the Contract between the parties hereto are expressly reaffirmed and remain in full force and effect.
