1. **AMENDMENTS.** For and in consideration of mutual promises and/or their valuable considerations, all provisions of the original master agreement resulting from Request for Proposal #99SWC-S1154 and dated November 7, 2022, attached hereto as Exhibit A, remain in full force and effect with the exception of the following:

- A. Section 2, entitled "TERM" is now amended for an extension to 12/31/2028 so the new range of the term will be 01/01/2023 – 12/31/2028.
- B. Effective upon execution of this amendment, the price list attached is effective. This amendment recognizes the Federal Communications Commission ruling of 7/18/2024 setting the new price caps for per-minute pricing on phone/video call rates and prohibits "site commission" payments.

2. **INCORPORATED DOCUMENTS.** Exhibit A (Original Master Agreement) is attached hereto, incorporated by reference herein and made a part of this amended master agreement.

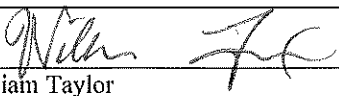
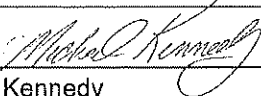
