

AMENDMENT NO. 02 TO NASPO MASTER AGREEMENT 23024

THIS AMENDMENT is by and between the State of Minnesota, acting through its Commissioner of Administration ("State"), and J.C. Technology, Inc. (dba Ace Computers), 340 Howard Ave., Des Plaines, IL 60018 ("Contractor").

WHEREAS, the State has an agreement with the Contractor identified as NASPO Master Agreement 23024, July 6, 2023, through June 30, 2026 ("Master Agreement"), to provide Computer Equipment, Peripherals, & Related Services; and

WHEREAS, Minn. Stat. § 16C.03, subd. 5, affords the Commissioner of Administration, or delegate pursuant to Minn. Stat. § 16C.03, subd. 16, the authority to amend contracts; and

WHEREAS, the terms of the Master Agreement allow the State to amend the Master Agreement as specified herein, upon the mutual agreement of the Office of State Procurement and the Contractor in a fully executed amendment to the Master Agreement.

NOW, THEREFORE, it is agreed by the parties to amend the Master Agreement as follows:

1. That Master Agreement 23024 is extended to June 30, 2027, at the same terms, conditions, and pricing.

This Amendment is effective beginning July 1, 2026, or upon the date that the final required signatures are obtained, whichever occurs later, and shall remain in effect through contract expiration, or until the Master Agreement is canceled, whichever occurs first.

Except as herein amended, the provisions of the Master Agreement between the parties hereto are expressly reaffirmed and remain in full force and effect.
