Recitals

1. The Parties entered into a Contract (MA2025008) for Cybersecurity and Information Security Services for NASPO ValuePoint, effective November 1, 2025.
2. With this Amendment No. 1, the Parties desire to renew the contract and obtain Contractor certification of the Americans with Disabilities Act WCAG 2.1 level AA requirements, as further detailed below.

Agreement

Based on the above recitals, and good and valuable consideration, the receipt of which is hereby acknowledged, the Contract is amended as follows:

1. The Contract is renewed from November 1, 2026, to October 31, 2027.
2. The Contractor shall ensure all digital products, services, and content provided under this Agreement comply with the Americans with Disabilities Act (ADA), Section 508 (as applicable), and WCAG 2.1 Level AA. Specific requirements are outlined in [Web Content Accessibility Guidelines \(WCAG\) 2.1 AA](#).

This requirement applies to all websites, applications, software, documents, multimedia, and any digital tools or services provided or procured for the State of Idaho.

Failure to meet WCAG 2.1 Level AA may result in any remedies available under Idaho procurement law, including but not limited to:

- Requiring the Contractor to cure deficiencies
 - State-performed testing or remediation at no cost to the State
 - Withholding payment
 - Termination of the Contract
3. Except as expressly modified in this Amendment, all other terms and conditions of the Contract remain in full force and effect.
4. This Amendment is effective upon the date of the last signature below. In no event will this Amendment be effective until executed by the Department of Administration.
