First Amendment

This First Amendment to Master Agreement OK-MA-145-21-600 (the “First Amendment”) is effective July 1, 2023, between the State of Oklahoma by and through the Office of Management and Enterprise Services in conjunction with NASPO ValuePoint and Neology, Inc. This First Amendment is a Contract Document in connection with Master Agreement OK-MA-145-21-600 (“OK-MA-145-21-600”).

This First Amendment supplements and amends OK-MA-145-21-600 entered into by the parties, which is incorporated by reference. Unless otherwise indicated, capitalized terms used in this First Amendment without definition shall have the respective meanings specified in OK-MA-145-21-600.

This purpose of this First Amendment is to further clarify the Initial Term as identified in “Section II. Term of Master Agreement, Section 2.1 Initial Term.” No other changes are made. The below section shall now read as follows:

Term of Master Agreement

2.1 Initial Term. The initial term of this Master Agreement shall begin on July 1, 2023 and is for two (2) years. The term of this Master Agreement may be amended beyond the initial term for three (3) additional years at the Lead State’s discretion and by mutual agreement and upon review of requirements of Participating Entities, current market conditions, and Contractor performance.

NOW, THEREFORE, in consideration of the foregoing and mutual promises set forth herein, the receipt and sufficiency of which are hereby acknowledged the parties have caused this Contract to be duly executed intending to be bound thereby.
