While CVE has confirmed that Cunningham Business Systems, L.L.C. is presently, as of the issuance of this notice, in compliance with the regulation, Cunningham Business Systems, L.L.C. must inform CVE of any changes or other circumstances that would adversely affect its eligibility. Eligibility changes not reported to CVE within 30 days could result in a referral to the Office of Inspector General (OIG), a referral to the Debarment and Suspension Committee, and the initiation of cancellation proceedings—all of which could result in Cunningham Business Systems, L.L.C. being removed from the VIP Verification Program.

Additionally, this letter and other information pertaining to Cunningham Business Systems, L.L.C.'s verification application may be subject to Freedom of Information Act (FOIA) requests. However, FOIA disclosures include exceptions regarding the personal privacy of individuals, and VA policy similarly provides limitations on the release of individuals records.

If Cunningham Business Systems, L.L.C. receives a negative size determination from the U.S. Small Business Administration (SBA), CVE must act in accordance with 38 CFR § 74.2(e). Also note, if at any time Cunningham Business Systems, L.L.C. discovers that it fails to meet the size standards for any NAICS Code(s) listed on its VIP profile, CVE requires such NAICS Code(s) be removed within five (5) business days. 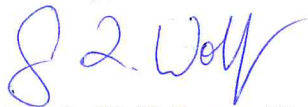
