1. PARTIES

This Amendment (the “Amendment”) to the State of Colorado Master Agreement shown on the Signature and Cover Page for this Amendment (the “Contract”) is entered into by and between the Contractor, and the State.

2. TERMINOLOGY

Except as specifically modified by this Amendment, all terms used in this Amendment that are defined in the Contract shall be construed and interpreted in accordance with the Contract.

3. AMENDMENT EFFECTIVE DATE

This Amendment shall not be valid or enforceable until its Effective Date. The State shall not be bound by any provision of this Amendment before that Amendment Effective Date.

4. FACTUAL RECITALS

- A. The Parties entered into the Contract effective August 1, 2024, for the provision of Multi-Function Devices and Related Software, Services and Cloud Solutions, as set forth in Contract #187846.
- B. The Parties modified the Contract effective January 23, 2025, to revise language in Attachment 1, Attachment 2, Attachment 4, and Attachment 5, as set forth in Amendment #1, Contract #196482.
- C. The Contract was modified to allow price increases related to unforeseen economic circumstances, as set forth in Amendment #2, CMS #199858, which was effective on June 5, 2025.

5. PURPOSE

The purpose of this Amendment is to extend the Contract for an additional term, per Section 2.2 of the Master Agreement.

6. MODIFICATIONS

The Contract, and all prior amendments thereto, shall be extended through July 31, 2027.

7. LIMITS OF EFFECT

This Amendment is incorporated by reference into the Contract, and the Contract and all prior amendments or other modifications to the Contract, if any, remain in full force and effect except as specifically modified in this Amendment. Except for the Special Provisions contained in the Contract, in the event of any conflict, inconsistency, variance, or

contradiction between the provisions of this Amendment and any of the provisions of the Contract or any prior modification to the Contract, the provisions of this Amendment shall in all respects supersede, govern, and control. The provisions of this Amendment shall only supersede, govern, and control over the Special Provisions contained in the Contract to the extent that this Amendment specifically modifies those Special Provisions.
