This MODIFICATION #1 is an Agreement between the Commonwealth of Virginia, hereinafter referred to as "State" or "Commonwealth," and Alamo Group Ag Americas LLC, formerly Bush Hog LLC, a Delaware limited liability company, hereinafter referred to as the "Contractor" or "Alamo Group", relating to the modification of Master Agreement number 61514 effective November 1, 2024, as amended, hereinafter referred to as the "Contract" or "Agreement." This Modification is hereby incorporated into and made an integral part of the Agreement.

The purpose of this modification is to document both parties' agreement to the following: A.) Update Master Agreement B.) Supplier Name Change. All changes are effective upon full execution of this document, unless otherwise noted, and shall be included in any subsequent modifications.

- A. **Reference:** Master Agreement 61514, RhinoAg LLC was merged into Bush Hog LLC on December 31, 2024. Therefore, RhinoAg LLC's Master Agreement is assigned and made a part of Bush Hog LLC's Master Agreement. Products, pricing, and contract terms remain unchanged, and Bush Hog LLC accepts and assumes all of RhinoAg LLC's past, present, and future rights and obligations.
- B. **Reference:** Master Agreement 61514, Bush Hog LLC's name is hereby changed to Alamo Group Ag Americas LLC. All products, pricing, and contract terms remain unchanged.

The foregoing is the complete and final expression of the parties' agreement to modify Master Agreement 61514 and cannot be modified, except by a writing signed by the duly authorized representatives of both parties. All other terms and conditions remain unchanged.

FIFTH: The certificate of formation of Bush Hog LLC in effect immediately prior to the effective time of the merger shall be the certificate of formation of the Surviving Entity, provided that, as of the effective time of the merger, the certificate of formation shall be amended to change the name of the Surviving Entity to “Alamo Group Ag Americas LLC” and, as amended, shall be the certificate of formation of the Surviving Entity until thereafter amended as provided therein or be applicable law.

SIXTH: The executed Plan of Merger is on file at a place of business of the Surviving Entity, located at 1627 E Walnut St, Seguin, Texas 78155.

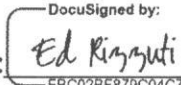

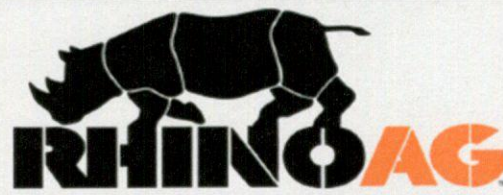
