



Wah-Tiah-Kah Scholarship

In 1871 the Osage moved to what is now known as the Osage Reservation of Oklahoma. Prior to the move, a tribal member--who was adept at surveying--traveled to Oklahoma from Kansas to determine boundaries and whether it was a wise move. Wah-Tiah-Kah walked the land. As he walked, he envisioned his grandchildren prospering. He knew this was good and Wah-Kon-Tah had blessed the land for the Wah-Zha-Zhi. It was known to our people that the land had a black substance that was pooled in many places across our hunting ground. We honor Wah-Tiah-Kah. Without his wisdom, we would not have the oil that has sustained the Osage for over 100 years.

PURPOSE

The purpose of the student award program as administered by the Osage Minerals Council is to provide Higher Education assistance to eligible Osage applicants in their educational pursuits in a petroleum related field of study.

REQUIREMENTS FOR ELIGIBILITY

- Must possess a Certificate of Degree of Indian Blood (CDIB) showing Osage blood quantum or an Osage Nation membership card.
- Be enrolled full time in an accredited post-secondary educational program including college, university, or technical school.
- Submit a completed application and correct documentation by deadline date.

HOW TO APPLY

To be considered for a scholarship, a student must complete an application and submit all required documents on or prior to the deadline. Applications are available from the Osage Minerals Council and may be requested by mail, email, or phone. They can also be printed from the OMC webpage.

DEADLINES

FALL SEMESTER – AUGUST 1

SPRING SEMESTER – JANUARY 1

Wah-Tiah-Kah Scholarship

GENERAL INFORMATION

- This is a ONE semester scholarship. Students must apply each semester to be considered for an additional semester scholarship. It does NOT renew automatically.
- Students must maintain a 2.0 GPA.
- Student may be funded for a total of eight semesters.
- FAXED applications will not be accepted!

AWARD CRITERIA

Each application is only considered for the semester for which funding is applied. Applications, whether funded or denied, must be resubmitted each semester. If you are re-applying, you may use your previously completed form with updated educational information and transcripts.

In addition to the items listed in Requirements for Eligibility, applicants should also send the following:

- Official high school transcript OR official transcript from post-secondary institute (whichever is most recent)
- School admission notice
- ACT or SAT test score
- Two brief letters of recommendation. Letters may be from high school or the post-secondary institute attending. If a student is returning to school as a non-traditional student, a letter from an employer will suffice.
- Personal statement of educational and career goals.
- A recent photo

It is the applicant's responsibility to ensure the Osage Minerals Council receives all required documents on or before the deadline.

APPLICATION DEADLINES

FALL SEMESTER – AUGUST 1

SPRING SEMESTER – JANUARY 1

- If the deadline date falls on a weekend or federal holiday, applications must be received at the OMC office by the close of business on the workday prior to the deadline.

PAYMENT OF SCHOLARSHIP

Scholarship payments will be processed when verification of enrollment and grades are received at the Osage Minerals Council office.
