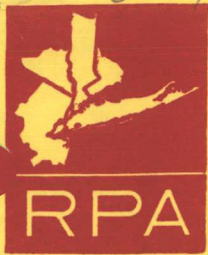

Governor Rockefeller will be honored with a new award to be inaugurated by the Association.

The Governor will deliver a major address and George A. Roeder, Jr., Vice Chairman of Chase Manhattan Bank, will speak briefly. Morris D. Crawford, Jr., Chairman of Regional Plan Association and Chairman of the Bowery Savings Bank will be master of ceremonies and present the award to the Governor. He will also summarize the all-day discussions that will precede the dinner at the Association's annual conference.

The all-day conference, the first public presentation of the New York City comprehensive plan, will bring together some 2,000 persons, the Association announced. Andrew Heiskell, Chairman of Time Inc., is the luncheon speaker. City Planning Commission Chairman Donald H. Elliott will be the main speaker in the morning.
