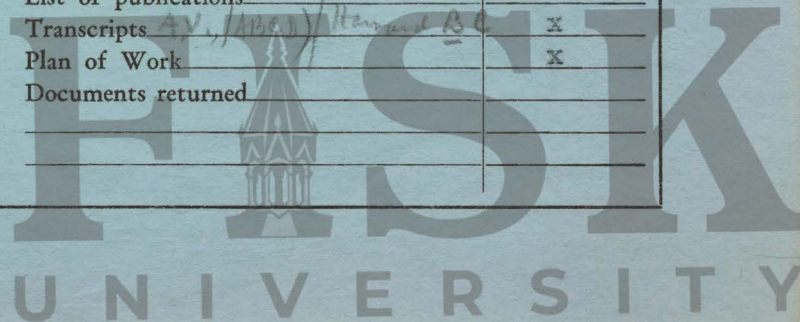

CAREER SINCE TENURE OF FELLOWSHIP

On returning to Atlanta Dr. Butler resumed his private practice of medicine, now limited to internal medicine and diagnosis. With two white physicians he is serving on the medical staff of the Child Welfare Association of Fulton and DeKalb County. This staff serves both white and Negro clients. He has worked during the past year with the Fulton County Health Department, holding two pediatric clinics a month in the Atlanta suburbs. Dr. Butler has also organized and headed the medical advisory committee of the Family Welfare Society, Negro Division. This is a committee of 8 physicians selected for their social mindedness as well as their clinical interests and training. 9/24/40

5/13/42 Dr. Butler engaged in private medical practice in Quincy, Massachusetts, for about two years. In the spring of 1942 he was appointed a Captain in the Medical Corps, and is now stationed at Fort Huachuca, Arizona.
