AIR PASSAGE CONTRACT

In consideration of the issuance of this ticket, the passenger agrees:

DATE: This ticket is valid only for trips and between points shown on the flight coupons. When trips are not specified, it is valid only for sixty days after date of issue. Flight coupons must be used in order and are not valid if detached.

CANCELLATION: The carrier may cancel any trip at origin or at any point and may omit any scheduled stop, its liability in such event being limited to a refund of the unused mileage proportion of the fare paid.

REFUNDS AND RESERVATION CHARGES: The carrier will refund the fare upon surrender of this ticket before departure, except that upon cancellation of a reservation less than three hours before scheduled departure a reservation charge may be made.

BAGGAGE: 35 pounds of baggage will be carried on each full fare ticket without additional charge. The liability of the carrier for loss or damage to baggage

or personal property or for delay in the delivery thereof is limited to its value which cannot exceed \$100.00 per passenger, unless a higher valuation is declared in advance and an additional charge is paid therefor.

DELAYS: The carrier shall not be responsible for failure of planes to depart or arrive on scheduled time.

REVOCABLE: This ticket is revocable by the carrier upon refunding the fare.

CONNECTING LINES: In selling a ticket or checking baggage beyond its own lines the issuing carrier acts only as agent for connecting carriers. This contract shall apply to each carrier named on this ticket and each shall be liable only for its own acts or omissions.

AGENTS: No agent or employee is authorized to alter, modify or waive any conditions hereof.

NOTICE AND SUIT: No action shall be maintained for loss or damage to the passenger's property or injury to his person, unless notice of the claim is presented in writing to the carrier within thirty days after the occurrence of the loss, damage or injury, and unless the action is actually commenced within one year after such occurrence.

NOT TRANSFERABLE: This ticket is not transferable, but the carrier shall not be responsible to the purchaser for its unauthorized use.

REGULATIONS: The passenger shall comply with the rules and regulations of the carrier and the instructions of its agents and employees.
