The Fairfax Hotel shall not be liable for any damage occasioned by failure to keep said premises in repair and shall not be liable for any damage done or occasioned by or from plumbing, gas, water, steam, or other pipes, or sewerage, or the bursting, leaking or running of any tank, wash-stand, water-closet, or waste-pipe in, above, upon or about said building or premises nor for damage occasioned by water, snow or ice being upon or coming through the windows, doors or otherwise, nor for any damage arising from acts or neglect of co-tenants, or other occupants of the same building, or of any owners or occupants of adjacent or contiguous property; nor shall the Fairfax Hotel be liable or responsible in any way or to any extent for any theft or pilferage of, or any injury to, any property of the guest or any other person, contained in said apartment, by any maid, janitor or other employee of the Fairfax Hotel or any other person, or howsoever occasioned.

The Hotel shall not be liable for any loss or damage of or to any property placed in any store room, trunk room or other storage place in the building, such store room or storage place being furnished gratuitously.

No outside radio aeriols or leads will be allowed.

Cooking of strong smelling foods not permitted.
