FELLOWSHIP AWARDS

In view of the fact that the fellowships for the coming year will not be awarded until after this meeting of the trustees, we cannot give a list of these awards. Instead, the fellowship director will report orally on the state of this year's selections.

ANTHROPOLOGY

Allison Davis: for studies in anthropology, at the University of Chicago.

Born 1903, Washington, D. C. Williams College, A. B., 1924; Harvard University, M. A., 1925, 1931-32; University of London, School of Economics and the Biometrical Institute, 1932-33. Professor of anthropology and head of the Division of Social Studies, Dillard University.

Mr. Davis continues his exceptional work. He is co-author with John Dollard of Children of Bondage, published this fall by the American Council on Education.

J. G. St. Clair Drake: for studies in social anthropology, at the University of Chicago.

Born 1911, Suffolk, Virginia. Hampton Institute, B. S., 1931; Pendle Hill School for Social and Religious Study, Wallingford, Pennsylvania, 1931-32. Research assistant and instructor in social anthropology, Dillard University.

Mr. Drake is at present associate director of the Illinois State Commission on the Condition of the Urban Colored Population. During the past year he worked on a memorandum on Negro organizations for the Carnegie study of The Negro in America. "Churches and Associations in the Chicago Negro Community", a W. P. A. report which Mr. Drake helped prepare, will be published in November, 1940 by the Institute for Juvenile Research. Mr. Drake is also working with Mr. Lloyd Warner and Mr. Horace Cayton on a book dealing with the Negro in Chicago.

Mr. Alsup is one of the ablest students in the Department of Zoology at the University of Pennsylvania in recent years. It seemed wise to continue our grant for another year and thus enable him to obtain his Ph. D. degree in 1941.

Percy H. Baker: for the study of biology and the preparation of school texts in science, at the University of Michigan.

Miss Goin married Edward N. Palmer, one of our 1939 Fellows. She is this year a part-time graduate student at the University of Michigan, where Mr. Palmer is pursuing his graduate work under our fellowship.

Ruth Smith Lloyd: for studies in anatomy and endocrinology, at Western Reserve University.

Myron B. Towns: for studies in physical chemistry, at the University of Michigan.

Mr. Towns will receive his Ph. D. degree in June of 1941. He returned in September, 1940, to his post at the A and T College in Greensboro.

Charles E. Weir: for research in nuclear chemistry and quantum mechanics, at the California Institute of Technology.

Mr. Weir is another of the students who have made distinguished records at California Institute of Technology, though his studies were interrupted by illness a year ago. He is at present attending the Institute and working part time in Pasadena.

Henry S. Wilson: for research in the plasticities of lime, at Indiana University.

Born 1902, Louisville, Kentucky. Indiana University, A. B., 1923, A. M., 1927. Instructor in chemistry and chairman of the Division of Natural Sciences, Louisville Municipal College.

Mr. Wilson received his Ph. D. degree with honors in chemistry at Indiana University. He has had two changes in rank since he returned to Louisville Municipal College where he is now associate professor of chemistry.

CLASSICS

Frank M. Snowden, Jr.: for studies in the classical languages, literature, and archaeology, at Harvard University.

Born 1911, York County, Virginia. Harvard University, A. B., 1932, A. M., 1933. Instructor in classics, Spelman College.

Mr. Snowden studied at the American Academy in Rome during the summer of 1938, and spent the remainder of his fellowship year at Harvard, where he made an excellent record. He has shown great ability to stimulate interest in the classics. After four successful years in the Atlanta University system he has moved to Howard University, where he is instructor in classics.

CREATIVE WRITING

William A. Attaway: for the writing of a novel dealing with the Pittsburgh industrial area and the Negro's place in the steel mills.

Arna W. Bontemps: to gather material for an historical novel and for books in the children's field.

1938 - \$1,900

Born 1902, Alexandria, Louisiana. Pacific Union College, B. A., 1923; University of Chicago, 1936-38. Principal of Shiloh Academy, Chicago.

During his fellowship Mr. Bontemps completed Drums at Dusk, a novel dealing with the slave uprising in Haiti. This was published by Macmillan in April, 1939. An autobiography of W. C. Handy, edited and prepared for publication by Mr. Bontemps, will be published by Macmillan in the spring of 1941. During the past summer he did research in Negro history for the Negro Exposition in Chicago. He is now serving as editor in the Illinois Writers' Project, Works Progress Administration.

Frank Marshall Davis: for creative writing, especially poetry.

Born 1905, Arkansas City, Kansas. Kansas State College, 1924-27, 1929-30. Feature writer, Associated Negro Press, Chicago.

Since Mr. Davis completed work under his fellowship his verse has appeared in various magazines and in a brochure, Through Sepia Eyes. Five of his poems were chosen for the anthology, Negro Voices, which appeared

in November of 1938. During his fellowship Mr. Davis brought toward completion a first novel and compiled verse for his third volume of poetry, but neither book has been published. He resumed his post as feature writer for the Associated Negro Press, and with this as a basis of livelihood is continuing his free lance writing.

ECONOMICS

Brailsford R. Brazeal: for a study of the origin and development of the Brotherhood of Sleeping Car Porters, at Columbia University.

Born 1903, Dublin, Georgia. Morehouse College, A. B., 1927; Columbia University, A. M., 1928, 1932-33. Teacher of economics and dean of men, Morehouse College.

Mr. Brazeal completed his residence work toward his Ph. D. degree and is working on his thesis. He was made professor of economics on his return to Morehouse College.

William H. Dean, Jr.: for a study of economic factors in regional migration and the growth of cities, at Harvard University.

Born 1910, Lynchburg, Virginia. Bowdoin College, A. B., 1930; Harvard University, M. A., 1932. Instructor in economics, Atlanta University.

Mr. Dean received his Ph. D. from Harvard University in June, 1938. His fellowship was renewed for 1939 for study in France and Sweden, but he was unable to go abroad that year and the war prevented his leaving at a later date. He therefore has relinquished the grant.

During the summer of 1939 Mr. Dean served as lecturer in economics at the College of the City of New York.

After his second year of study under fellowship Mr. Dean returned to Atlanta University as assistant professor of economics. He has just been appointed a consultant with the National Resources Planning Board, and will work on two studies, "The Location of Defense Industry" and "Transportation Policy".

Abram L. Harris: for the completion of a study of the ideas of Karl Marx and Thorstein Veblen.

Born 1899, Richmond, Virginia. Virginia Union University, B. S., 1922; University of Pittsburgh, M. A., 1924; Columbia University, Ph. D., 1931. Professor of economics and head of the department, Howard University.

Mr. Harris is still at work on the Marx-Weblen study. He continues to carry on a very active writing and research program. His latest study, "Collective Bargaining and the Federal Law", is an examination of the legal principles and the machinery of federal collective bargaining statutes since 1888.

John Hope II: for a study of consumption habits and credit practices among low-income families in the South, at the University of Chicago.

Born 1909, Atlanta, Georgia. Morehouse College, A. B., 1930; Brown University, A. M., 1932; University of Chicago, 1938. Teacher of economics, Spelman College and Atlanta University.

Giles A. Hubert: for a study of agriculture and farm organization, in Denmark.
1937 - \$2,700

Born 1907, Atlanta, Georgia. Jackson College, B. A., 1928; State University of Iowa, M. A., 1930; University of Minnesota, 1930-31. Assistant professor of economics and rural sociology, Fisk University.

Mr. Hubert returned to his post at Fisk University at the end of his fellowship. He immediately found himself in great demand in government and other planning for agriculture, and he has been dividing his time between Fisk University and the Farm Security Administration. He is at present assistant to the director, Rural Rehabilitation Division, Farm Security Administration.

Mr. Hubert played a leading part in bringing about cooperation among Fisk University, Tuskegee Institute, and the FSA in the training of rural leaders. He has also been instrumental in initiating a program for the rehabilitation of Negro farming communities, already under way in ten states of the Southeast.

George F. McCray: for study of interracial conflicts in the labor movement, under the auspices of the University of Chicago.

Born 1908, Biloxi, Mississippi. Mr. McCray has no degree, but he has studied labor problems at the University of Chicago and the University of Wisconsin. Assistant superintendent, labor research project, Illinois State Employment Service.

At the end of his fellowship tenure Mr. McCray returned to his post with the Illinois State Employment Service.

Booker T. McGraw: for studies in economics, specifically the monetary experience of France from 1926-1937, at Harvard

Jacob L. Reddix: for a study of the possibilities of cooperative societies among Negroes, at the University of Chicago.

Born 1900, Savannah, Georgia. Hampton Institute, B. S. A., 1927; University of Wisconsin, B. S. A., 1928, M. S., 1932. Project manager, Soil Conservation Service, U. S. Department of Agriculture, stationed at Tuskegee Institute.

William J. Trent, Jr.: for an analysis of occupational trends and opportunities among Negroes in northern cities, at the University of Pennsylvania.

Born 1910, Asheville, North Carolina. Livingstone College, North Carolina, B. A., 1930; University of Pennsylvania, M. B. A., 1932, 1936-37. Adviser on Negro Affairs, Public Works Administration, Washington, D. C.

Soon after his fellowship was awarded, Mr. Trent was offered the position of Adviser on Negro Affairs in the Office of the Administrator of the Federal Works Agency, Washington. His fellowship has, therefore, been postponed for a year.

EDUCATION

David W. Cannon, Jr.: for studies in education, at Teachers College, Columbia University.

Mr. Cannon completed all examinations for his Ph. D. degree and wrote the larger part of his dissertation. His death in December of 1938 cut short what promised to be a brilliant and useful career in education.

Robert Coleman, Jr.: for studies in mathematics and education, at Columbia University.

Born 1914, Dallas, Texas. Western Reserve University, A. B., 1935; Columbia University, M. A., 1937. Instructor of physics, Wilberforce University.

Marion Cuthbert: for a study of Negro college women and their position in American life, at Teachers College, Columbia University.

Born 1896, St. Paul, Minnesota. Boston University, B. S., 1920; Columbia University, M. A., 1931. Secretary on the Department of Study Staff, National Board of the Y. W. C. A., New York City.

Matthew L. Fairfax: for study leading to the development of a program in industrial arts suitable to the needs of Negro children, under the auspices of the University of Cincinnati.

Born 1911, Eagle Rock, Virginia. West Virginia State College, B. S., 1934. Instructor of industrial arts and mathematics, Milford Junior High School, Milford, Delaware.

H. Councill Trenholm: for studies in educational administration, at the University of Chicago.

Born 1900, Tuscumbia, Alabama. Morehouse College, A. B., 1920; University of Chicago, Ph. B., 1921, A. M., 1925, 1934-35. President of Alabama State Teachers College.

Mr. Trenholm returned to his post as president and director of instruction at State Teachers College, Montgomery, Alabama.

ENGLISH

A. Russell Brooks: for studies in English literature, with particular reference to the drama, at Columbia University.

Born 1906, Montgomery, Alabama. Morehouse College, A. B., 1930; University of Wisconsin, M. A., 1934; University of Edinburgh, 1938-39. Professor of English and head of the department, Negro Agricultural and Technical College,

Greensboro, North Carolina.

Mr. Brooks was originally appointed for work at the University of Edinburgh, where he was studying at the time of making application. Research opportunities became so restricted at the outbreak of the war that he requested permission to use his grant for work at Columbia University. At the close of his fellowship period he returned to his post at the North Carolina A and T College.

Richard A. Carroll: for studies in English literature, at the University of Michigan.

Born 1913, Valliant, Oklahoma. Johnson C. Smith University, A. B., 1934; University of Michigan, M. A., 1936. Instructor in English, Arkansas State College.

Mr. Carroll completed residence requirements toward his Ph. D. degree in English at the University of Michigan. He is now instructor in English at Johnson C. Smith University, Charlotte, North Carolina.

Charles T. Davis: for studies in the history of American culture, specifically a study of the literature of the Negro renaissance, at the University of Chicago.

Born 1900, Alcorn, Mississippi. Talladega College, A. B., 1923; Dartmouth College, A. B., 1924; Harvard University, A. M., 1926, 1931-33, 1937-38. Assistant Professor of English, Fisk University.

Mr. Lanier returned to his post at Fisk at the end of his fellowship tenure.

Hilda Lawson: for a study of English literature, at the University of Illinois.

Born 1914, Washington, D. C. Miner Teachers College, B. S., 1934; Howard University, M. A., 1935; State

University of Iowa, 1935-36; University of Illinois, 1936-37.

Miss Lawson received her Ph. D. in English in February of 1939, hers being the first doctorate conferred on a Negro woman by the University of Illinois. She is now assistant professor of English at Lincoln University, Missouri.

Ulysses G. Lee, Jr.: for studies in American culture and the preparation of a volume on the anti-slavery press, at the University of Chicago.

Born 1913, Washington, D. C. Howard University, A. B., 1935, M. A., 1936. Assistant professor of English, Lincoln University, Pennsylvania.

Youra Qualls: for studies in English literature, at Radcliffe College and Harvard University.

Born 1910, Clarksville, Texas. Fisk University, A. B., 1937. Teaching assistant in the English department, Fisk University.

Lorenzo D. Turner: for a study of Negro speech to determine the nature and significance of West African survivals in the speech, in Brazil.

Born 1895, Elizabeth City, North Carolina. Howard University, A. B., 1914; Harvard University, M. A., 1917; University of Chicago, Ph. D., 1926; University of London, 1936-37. Professor of English and head of the department, Fisk University.

Mr. Turner has had to delay work under his grant until this year. He is now in Brazil.

Art Education

Frances E. Thompson: for work in art and art education, in Czechoslovakia.

Born 1902, Nashville, Tennessee. Massachusetts School of Art, B. S., 1936. Teacher of art education and crafts, Tennessee Agricultural and Industrial State Teachers College.

Miss Thompson returned to her work at the State College. During the past year she has been asked to write a bulletin on art education for the State of Tennessee.

Drama

Fannin S. Belcher, Jr.: for studies in drama, at Yale University.

M. A., 1930. Assistant professor of English and di-
rector of dramatics, West Virginia State College.

At the end of his work under our fellowship, Mr. Belcher was granted an additional leave of absence by the West Virginia State College, and he is continuing his study toward the doctorate at Yale University.

Anna M. Cooke: for studies in drama, at Yale University.

1939 - 1,500 1928; American Academy of Dramatic Art, and Columbia
University, 1930-31; Yale University, 1936-37. Director
of dramatics, Spelman College.

By the end of her fellowship tenure Miss Cooke had completed all residence requirements for the Ph. D. degree and had done a good deal of work on her dissertation, "Theories of Acting".

Randolph Edmonds: for creative work in folk drama in Ireland and England, especially with the Irish Players.

Born 1900, Lawrenceville, Virginia. Oberlin College, A. B., 1926; Columbia University, A. M., 1931; Yale University, 1934-35. Professor of drama, Dillard University.

Mr. Edmonds and his department at Dillard continue to be exceedingly active. In addition to its campus productions the Dillard Players Guild has staged plays at several other colleges, among them Tougaloo, St. Augustine's, and Bennett, travelling some 2,000 miles during the year. Mr. Edmonds has made the drama department a center of activity for the area. He serves as president or director of several civic organizations and regional associations, and through these groups the University's drama program has touched many thousands in a wide area, thus influencing the development of drama in southern schools, colleges, and communities. He continues to write extensively.

Shirley Graham: for studies in the theatre and music, at the Yale University School of Fine Arts.

At the end of her 1939-40 year of study at Yale, Miss Graham accepted a position as director of adult activities of the Phyllis Wheatley Y. W. C. A., Indianapolis. She was offered a Yale fellowship for 1940-41 under which she would have continued her work with Mr. Allardyce Nicoll, but she had already accepted the post with the Y. W. C. A. and did not feel free to break her contract.

Music

Otis Holley Berry: for the study of voice at the Fontainebleau School of Music, France.

Ira Aldridge in London, summer and fall of 1936.

Mrs. Berry continues her teaching and voice study in Washington.

William Grant Still: for creative work in musical composition.

Born 1895, Woodville, Mississippi. Wilberforce University, 1911-15, M. Mus., 1936. Oberlin Conservatory of Music. Private study with George Chadwick and Edgar Varese.

Mr. Still is one of the important composers in America today. Unfortunately his work, however valuable, is not of a sort to attract financial reward. In the absence in modern society of those personal patrons who in an earlier era supported such artists, it is necessary for such agencies as the Rosenwald and the Guggenheim foundations to recognize and help support such exceptional talent.

One of Mr. Still's latest compositions, "And They Lynched Him on a Tree", was given its initial performance at a Lewisohn Stadium concert in June, 1940, under the direction of Doctor Rodzinski.
