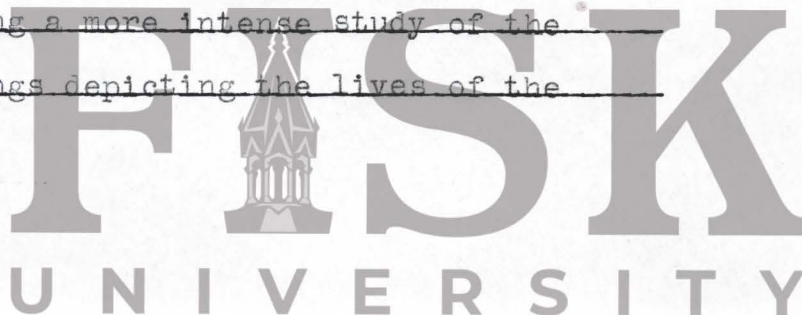
Concise statement of plan of work It is planned to complete a series of paintings that reveal characteristic aspects of the life of the Sea Island folk.
