## SCHOOL LIBRARIES

An appropriation of \$5,000 is requested in addition to the sum of \$12,500 appropriated in May, 1937, for school libraries.

The states of Georgia and Tennessee have this year allocated \$100,000 each for the purchase of libraries for public schools. This interest in school libraries is attributed by state officials very largely to the stimulus to the library movement in the South given by the Fund. The state librarian of Tennessee has discussed the possibility of the Fund's supplying our elementary and supplementary libraries in considerable quantity, and Mr. Cousins, State Agent for Negro Schools in Georgia, has said that it is more than likely that Georgia will want at least 1,000 sets. Although we have not yet definite applications from either state, it has seemed wise to put ourselves in a position to supply these libraries if and when they are ordered. Judging from the number of libraries which were sent out during 1936-37, the amount of money already appropriated will not be sufficient to cover the large extra orders that may come. Last year a total of 1,191 libraries were distributed (593 elementary and 598 high school).

It seems wise to cooperate with this new library movement, especially to help in getting the new funds used as far as possible in supplying reading materials to Negro and rural schools where they are so desperately needed. It is requested that an additional appropriation be made at this time with the understanding that only our usual number of libraries will be ordered until definite commitments are received from one or more of the states which are contemplating large increases in school libraries. It is understood of course that these additional libraries will be distributed exactly as is ordinarily done, that is, on the basis of two-thirds cost to Negro schools and full cost to white schools.

The following resolution is recommended -

RESOLVED that the sum of Five thousand dollars (\$5,000) be and it is hereby appropriated for school libraries in anticipation of extraordinary demands, it being understood that in general the schools concerned will pay not less than two-thirds the cost of the books.

## ADMISSION OF MARY ELISABETH MCKAY TO THE RETIRING ALLOWANCE TRUST

The Trust Agreement creating the Julius Rosenwald Fund Officers' and Employees' Benefit Trusts dated July 1, 1935, provides in Section IV-F that any officer or employee of the Fund, after he has completed two years of service and subject to the approval of the Executive Committee of the Fund, may become an employees' trust beneficiary by executing and delivering to the Fund and the Trustee duplicate copies of the instrument set forth in the Agreement. Mary Elisabeth McKay began her regular employment with the Fund on June 12, 1935. She has thus been in the service of the Fund for the period stipulated in the Agreement and she has delivered to the Fund and Trustee copies of the regular form requesting admittance as outlined in the Trust Agreement.

The following action is recommended:

RESOLVED that Mary Elisabeth McKay be and she is hereby accepted as an Employees' Trust Beneficiary under the Julius Rosenwald Fund Officers' and Employees' Benefit Trusts, created by Trust Agreement dated July 1, 1935, this action with respect to Mary Elisabeth McKay to be effective as of July 1, 1937.



## PAYMENT TO BENEFICIARY FROM RETIREMENT TRUSTS

The following is reported for the information of the Committee.

In accordance with the Trust Agreement dated July 1, 1935, establishing the Julius Rosenwald Fund Officers' and Employees' Benefit Trusts, payment of the following amounts was made to Mr. Clark Foreman in April, 1937, his status of a Fund employee on leave of absence to the government having ended during the preceding quarter. The payments below are based on the March 31, 1937, net worth of the two trusts.

Dear Edwin:

I am very sorry but I shall not be able to go to the meeting of the Fund on November 11. We have just gotten home from a wonderful trip to Sea Island and I don't feel that I can dash off to Chicago so near the time of our setting up housekeeping together.

I understood from Lessing that you were going to ask either Mrs. Roosevelt or Doris Biddle Duke to fill the remaining vacancy. I think this is much better than inviting both of them. I am afraid, however, that Mrs. Roosevelt would not come to many meetings and, from what I have heard since I spoke to you, I do not think that Doris Biddle Duke would be much of an asset. But I imagine all this comes too late to be of much use.

I feel very strongly that Adele Levy should be urged to go on the Board in my place. She would be a real asset, and I know that you will agree with me that in these closing years we need an unusually strong Board of Directors.

Dear Marion: Indeed we shall miss you. I am very sorry you cannot attend. While I have opposed your ideas which seemed to me to smack too much of the scholasticism of Hutchins, I have appreciated your enthusiastic interest. You have certainly been a fine yeast in our group.

I am inclined to agree with you in the matter of trustees. It would certainly be too much to bring on the two spectacular women at one time. I hope we can get Mrs. Roosevelt, though we do not yet have her answer. My only interest in putting on Mrs. Cromwell at some later date would be to try to educate her to begin to use her fortune constructively in that region of the country from which it originated. I am completely committed to Adele Levy to succeed you. As you probably know, Lessing suggested that it might be wise to get a representation from the third generation of Rosenwalds. We agreed to let him and Adele work this out any way they thought best. My vote, however, is for Adele.

At a meeting of the committee on the length of life of the Fund, held here in Chicago, it was suggested that each member outline his ideas and send them on to the other members of the committee. You have doubtless received the suggestions of General Wood and Frank Sulzberger. Here are mine. May we have a memorandum from you so as to have the thoughts of all members of the committee to present to the Board?

Even if you are not a trustee I hope I may continue to talk with you from time to time of things that we are doing and of other common interests.
