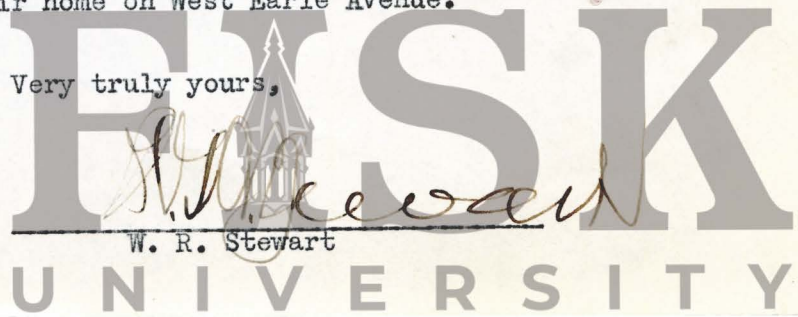
I have no personal knowledge of his ability as a physician, but can say he is well spoken of and I have heard my physician commend him.
