

## A SAFER FUTURE FOR ALL

Investing in REAL Community Safety





At MomsRising, we are clear. Every person, regardless of race, income, or zip code, deserves to feel safe. But the truth is, for far too long, the way we've been funding and structuring public safety in the United States isn't working. Our overreliance on policing has failed to deliver real safety while causing deep harm, especially in Black, Brown, Indigenous, and low-income communities. It's time to shift away from punitive systems and. It's time to shift away from punitive systems and toward public health-centered, community-based approaches that are already proving effective across the country.

The safest communities don't rely on more police. They have access to good schools, stable housing, jobs with fair wages, and strong public infrastructure. In contrast, excessive police funding has shown little correlation with crime reduction. For example, from 1985 to 2020, increased police spending in major cities did not lead to lower crime rates. Meanwhile, only 4% of police time is spent addressing violent crime, with most interactions involving traffic stops or nonviolent calls. We are also seeing an increase in police being called to respond to mental health crises, a growing community issue that police are neither trained for nor qualified to address in the types of ways that trained mental health professionals can.

There's hope with parents, caregivers, and communities showing that there's another way. Across the country, non-carceral, non-police-led initiatives are improving safety through prevention, care, and healing. These programs match the right response to the right need, connecting people in crisis to support, not harm, and punishment.



### **EXAMPLES OF COMMUNITY-BASED SAFETY THAT WORK**

### **Denver STAR Program**

The Support Team Assisted Response (STAR) program dispatches trained behavioral health professionals, rather than police, to respond to low-level, nonviolent 911 calls. In its first year, STAR responded to over 1,300 calls without a single arrest. The program helped reduce low-level crime by 34% in the areas it served.

### Treatment Not Trauma in Chicago

This growing initiative advocates for investing in mental health professionals and crisis teams instead of policing. It seeks to reopen city-run mental health centers and establish a 24-hour, non-police crisis response system. These reforms are rooted in the belief that mental illness should never be a death sentence.

### Credible Messenger Programs

In New York and Mississippi, formerly incarcerated individuals and community leaders with deep ties to their neighborhoods work directly with at-risk youth and adults. These messengers build trust, mediate conflict, and help break cycles of violence. Evaluations show they reduce recidivism and promote long-term behavioral change.

### **Mobile Crisis Response Teams**

Cities across the U.S. are implementing civilian response units made up of clinicians and social workers who handle mental health, substance use, and homelessness-related crises. These teams dramatically reduce unnecessary arrests, hospitalizations, and fatal police encounters.

### Offices of Violence Prevention

Cities like Newark and Philadelphia have established dedicated offices focused on interrupting violence before it happens. Newark's <u>Office of Violence Prevention and Trauma Recovery</u> uses a trauma-informed, community-rooted model. Philadelphia's <u>Office of Policy and Strategic Initiatives for Criminal Justice & Public Safety</u> coordinates violence prevention across agencies and has contributed to significant drops in shootings in targeted areas.

### LET'S BUILD THE FUTURE WE DESERVE

We don't have to choose between safety and care. We can have both, but only if we stop treating policing as the default response to every problem. It's time to invest in the people and programs that are already making our communities safer.

Families, caregivers, and community members: We have the power to advocate for real solutions. Let's demand that local, state, and federal leaders fully fund alternatives that center health, dignity, and safety for all of us.

Because everyone deserves a safe walk home. A peaceful night's rest. A tomorrow full of promise.



### WHY THIS APPROACH MATTERS

These programs work because they address the root causes of harm, poverty, trauma, mental illness, and disconnection. For example:

- Community violence intervention programs like Advance Peace have reduced gun homicides by 20–22% in the cities where they operate.
- Summer youth employment programs have cut violent crime among disadvantaged youth by up to 43%.
- Neighborhood improvement projects, like fixing vacant lots, installing streetlights, and building parks, consistently reduce crime and improve overall well-being.

These are not "soft on crime" strategies. They are serious, evidence-based approaches to public safety. They work because they meet people where they are with empathy, expertise, and effective and practical support.

### PUBLIC POLICY MUST FOLLOW COMMUNITY WISDOM

To truly scale these efforts, we need robust funding and policy support at all levels of government. Several federal bills offer a blueprint:

- >>> The People's Response Act would create a new Division on Community Safety at the Department of Health and Human Services to fund and coordinate public health approaches to safety nationwide.
- >>> The Mental Health Justice Act would fund state and local programs that send trained health professionals, not police, to mental health emergencies.
- >>> The Break the Cycle of Violence Act would invest in community violence intervention programs proven to reduce shootings and homicides.
- The Counseling Not Criminalization Act would redirect federal funds from school police to counselors, mental health staff, and restorative justice programs.

These policies acknowledge that safety isn't just about stopping crime, it's about preventing harm, building resilience, and investing in care over control.

### **COLORADO**

My son was on his way home and got a ride from his friend who had a truck. Two Sheriff's Deputies pulled the truck over two houses down from my house and said "the truck looked like a suspicious vehicle." When my son exited the vehicle, he said the deputies had their guns pointed at him as he explained that he lived two houses down and was getting a ride home.

The deputies both shot the tasers, hitting my son in the temple, cheek, forearm, and chest which caused a seizure. My son almost bit his tongue off during the brutal tasing and is now permanently disabled with epilepsy for the rest of his life.

The deputies charged him with attempting to disarm a peace officer because during his seizure he jerked the taser from his chest.

I told the cop we were just trying to free up my tires and would put the snow back when we did that. It finally seemed to satisfy the cop who was White as I am. The man helping me had his little boy with him. I have no doubt the cop would have arrested the man if I hadn't intervene.

### **NEW YORK**

I witnessed a frightening attack by New York City police against a small Black teenager who seemed to be running from the officers, in a subway station. At least twenty armed officers threw the young man to the ground and piled their entire bodies on top of him.

The adolescent was wearing a track suit and was slight in stature, clearly he had no sort of weapon and couldn't possibly pose a threat to the officers.

The officers were shouting wildly and had an air of intensity and lunacy about them. Other officers were yelling at me and other members of the public who were trying to get close to somehow help the young man.

### **TAMIR RICE**

### TRIGGER WARNING - GRAPHIC LANGUAGE

Just a few days before the Thanksgiving holiday in 2014, Tamir Rice, only 12 years old, was tragically killed by a police officer while playing with a toy gun in a Cleveland, Ohio, playground. Tamir was playing alone with a toy pellet gun when someone called 911 to report seeing a person playing with a real gun. Within seconds of arriving at the scene, two Cleveland police officers arrived at the park, drew



their guns at Tamir, and shot at him. The police gave him no verbal warning and made zero attempts to first assess the situation before shooting the 12-year-old twice. Biases and racism are so deeply ingrained in our system that, beyond Tamir being shot and in need of medical help, he was still not even given medical attention until several minutes later. Was he not worth immediate medical attention?

Tamir Rice passed away from his injuries the following day.

His death is one of many devastating examples in which police violence in predominantly Black communities underscores a painful and long-standing issue that continues to tear families and communities apart. The officers' failure to evaluate the situation properly, their failure to act rapidly without any attempt to de-escalate or even try to understand the context of the 911 call, and their unjustified fear of a young Black boy causing them immediately to draw their guns at him all speak volumes. It highlights the need for comprehensive, inclusive, holistic, and health-centered approaches, as well as police practices and training, to address crises that reduce harm and truly keep our communities safe.

Tamir's life, and the lives of many others, have led to the distrust and fear that many people live with every day— that they are not safe in their own homes, schools, churches, mosques, hospitals, and neighborhoods; that police officers are not people they can count on. The need for reform is urgent. Everyone deserves to feel safe where they live, every day, end of story. The People's Response Act offers a right step in that direction.

### A CALL TO REIMAGINE SAFETY, TOGETHER

At MomsRising, we believe every child deserves to grow up in a community where safety means care, not punishment, where help comes in the form of a trusted mental health professional, a mentor, a nurse, or a neighbor, not an armed officer, where public safety is not measured by arrests or incarceration, but by well-being, opportunity, and thriving neighborhoods.

The stories and data shared throughout this book make one thing abundantly clear: real safety doesn't start with handcuffs; it begins with healing. With investments in mental health care, youth development, housing, violence interruption, and crisis response rooted in public health.

These programs are working. Across the country, families and communities are building new paths forward, demonstrating that safety, justice, and care are interconnected when we prioritize connection over control.

### This is our invitation to you.

As legislators, city leaders, and changemakers, you have the power to stop the harm and start funding what works. You can shift resources away from systems that traumatize, towards programs that protect. You can co-create a future where every call for help is met with compassion and every child grows up with the support they need to thrive.

Let's build that future, BOLDLY and TOGETHER.

The time to reimagine community safety is now. Moms, caregivers, and families are ready. We need you to join us. Fund alternatives. Pass the legislation. Trust the community.

Let's rise, for safety, for justice, for care, and for each other.

### THE CASE FOR POLICE FREE SCHOOLS

The physical, social, and emotional well-being of children in schools is crucial to their success and safety.

Yet, 1.7 million students are in schools with police but no counselors, and 10 million students are in schools with police. Fourteen million students are in schools with police but no counselor, nurse, psychologist, or social worker. Many states reported two to three times as many police officers in schools as social workers, and five states reported more police officers in schools than nurses. This is unacceptable.

Research consistently demonstrates that the presence of police in schools serves as an entry point to the school-to-prison pipeline and disproportionately harms Black, Indigenous, and Latinx students; students with disabilities; and marginalized students. Study after study shows that there are virtually no gains from having police in schools.

There are measurable ways to increase school safety that don't promote the school-to-prison pipeline and have been proven to be successful. These measures include restorative approaches, more mental health staff and counselors, social-emotional learning, and trauma-informed care in our schools. The presence of school-based mental health providers not only improves outcomes for students but also enhances overall school safety.

We must take steps to shift resources away from practices that harm and push kids out of school into what helps students thrive, keeps schools safe, and ends the criminalization of kids in schools.




