The S/C/SC/H Series devices are for use as evacuation devices in all dwelling units, including but not limited to homes, apartments, hospitals, hotels and motels. Available in several different models, the S/C/SC/H Series is engineered to virtually eliminate nuisance alarms and deliver outstanding performance wherever reliable fire protection is required.

The S/C/SC/H Series is provided with a 9V alkaline battery for back-up in the event building power is lost. Options include self-restoring 135°F integral and isolated thermals with rate of rise and Form A/Form C dry contacts for remote annunciation.

The S/C/SC/H Series smoke, CO, smoke/CO and heat alarms are ANSI/UL 217, ANSI/UL 2034 and/or ANSI/UL 539 listed and are warranted for one year from date of purchase.

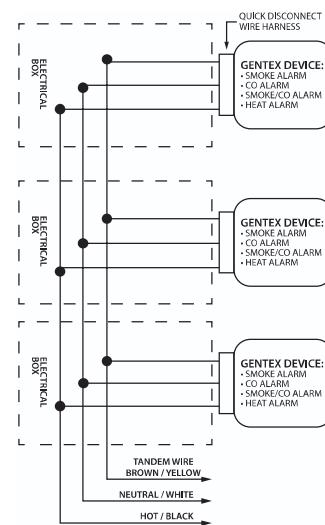

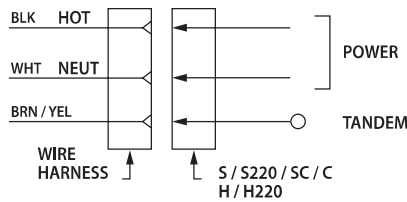

Tandem Interconnect Wiring Diagram



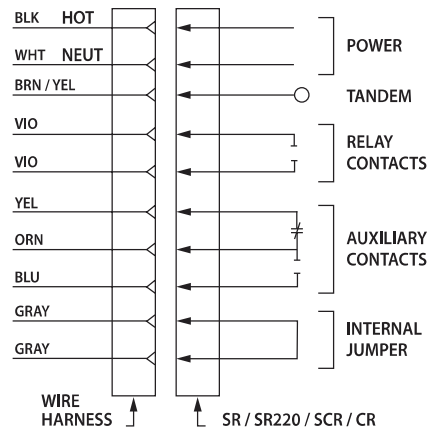

- When a C, CR, SC, SCR and/or SCRR is tandem interconnected with Gentex smoke alarms or combination smoke/CO alarms and smoke devices go into alarm, smoke alarms, CO alarms and/or combination smoke/CO alarms will sound the smoke alarm warning (temporal 3 horn pattern).
- When both smoke and CO conditions are present, smoke condition will have priority and alarms will sound smoke alarm warning (temporal 3 horn pattern).

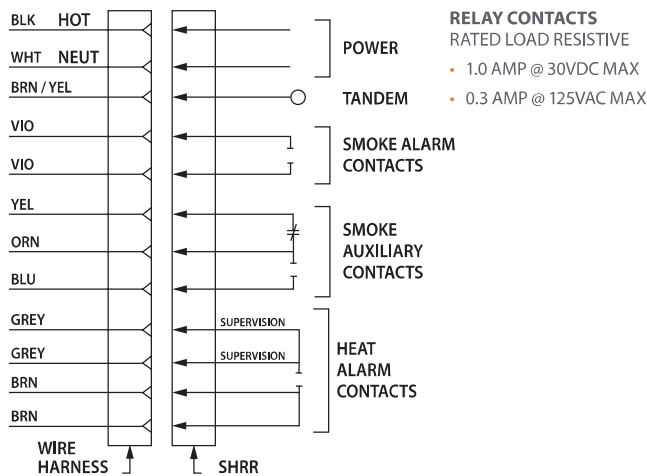

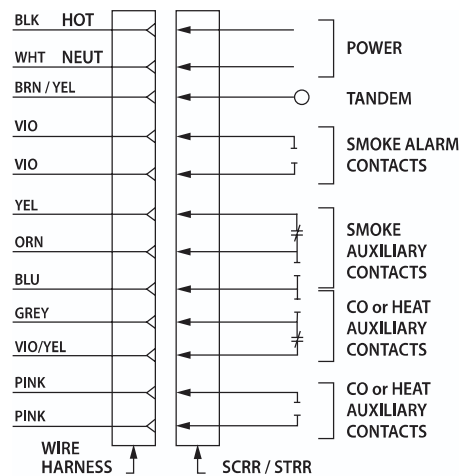

The multi-criteria smoke alarm shall be a Gentex model S/SR/STRR/SHRR/SC/SCR/SCRR/S220/SR220 or approved equal which shall provide at least the following features and functions.

- Nominal smoke sensitivity shall be 2.5%
- The alarm shall utilize a LED sensing circuit which pulses in 1 second intervals when subjected to elevated levels of smoke. After 2 consecutive pulses in smoke, the alarm will activate.
- Use only Duracell® MN 1604 battery with this device. Available at many retail stores.
- The alarm shall have a 9V alkaline battery as a back-up in the event building power is lost.
- The 9V alkaline battery impedance shall be verified by the circuit of the smoke alarm.
- The alarm shall provide an indicator when the battery is low in power, or high impedance, or is missing.
- The alarm shall provide minimum 5-to-1 signal-to-noise ratio in the optics frame to assure stability of operation in environments of high RF and transient conditions.
- The sensing chamber shall be fully screened to prevent entrance of small insects, thus reducing the probability of false alarms.
- A temporal 3 piezo alarm rated at 85 dBA at 10ft.
- A visual LED monitor (condition indicator) will slow pulse in normal operation and rapid pulse in alarm.

- The alarms shall have the interconnect capabilities of up to 18 initiation devices with a maximum of 12 S or SC series smoke alarms.
- The manufacturer shall provide other compatible alarm models with the following optional features: a) 135°F isolated thermal with normally opened contact for remote connection to local alarm or annunciator; b) 135°F integral thermal; c) auxiliary Form A/Form C relay contacts for initiating remote functions and annunciation; d) relay option that is capable of activation by tandem interconnect wire. Thermal sensor shall be self-restoring.
- Unit must be ANSI/UL 217, ANSI/UL 2034 and/or ANSI/UL 539 listed for both wall and ceiling mount.
- Unit shall be listed by Underwriters Laboratories.

All equipment shall be completely factory assembled, wired and tested, and the contractor shall be prepared to submit a certified letter testifying to this condition. Alarms which do not meet all of the requirements of this specification will not be considered.
