

Directed by Sergei Eisenstein; scenario by Sergei Eisenstein; photography by Eduard Tisse and Andrei Moskvin; music by Sergei Prokofiev; starring Nikolai cherkassov.

part One will be shown on Saturday night and Part Two on Sunday night.

Fach part will be shown only once.

Ivan the Terrible, I & II, were Eisenstein's last two films. These films continue the collaboration of Eisenstein, prokofiev, Tisse, and Cherkassov which began with the making of Alexander Nevsky. Again, Eisenstein (the most intellectual of directors), has woven a complex tapestry from the threads of historical events.

The film takes place in the Moscow of the 16th century, when Ivan Alexieff is crowned Czar. It is the chronicle of Ivan's struggle to drive out the Mongols, foil the plots of the Boyars, and to unify all of Russia. It traces the many changes in the character of Ivan. we see how in fighting the Boyar's continual plots he becomes ever more paranoid, ever more twisted. Ivan is clearly the hero of this film, yet the change in Ivan's character so amirably chronicled by Eisenstein is not the usual change which we expect in the hero. Even as Ivan's mind becomes ever more poisoned and distorted so does Cherkassov's body become ever more twisted. Due to the parallels between Ivan and Stalin in Part II, its release was held back. Also, parts of the second part of this film are in Agfacolor, the process having been captured by the russian Army in its drive on Berlin.

Parker Tyler, in Classics of the Foreign Film, says of Ivan the Terrible that: "Eisenstein, having matured since the year of Nevsky (1938), was reaching towards new heights of imaginative splendor, more enlightened, more comprehensive. The turth was that this film-maker understood that no great hero of actuality should be idealized exclusively as an instrument of social forces, as a simple measure of his nation's glory. Co-existent with the image of an historic hero thus defined, must be his image as an individual hero, a humanized image concerned with the in-

ner drama, the private fate, of a per-

The evidence shows that Eisenstein's view of Ivan the Terrible, precisely from the encyclopedic angle, converted his film into a dialectic between Ivan the ruler and Ivan the man:"

FOR A STUDENT GOVERNMENT TO BE AN influence on the school, other than regulating party funds, it must have a strong Executor that can stand up to hard-nosed administrators, stone-faced -crazed (fill in the faculty, and blank yourself) students. An Executor of this sort is liable to step on a few toes (hopefully, not his own) while pushing an innovation; however, the checks on the Executor (the Polity Constitution, the Administration, and the Student Government itself) would keep a strong Executor from pedicular amputation. We have such an Executor now. Mr Jerrems is feisty enough to be able to deal with most obstructions to Delegate Council projects. Although this bullheadedness can lead to his going overboard on some issues, he can be stopped. There is nothing to be said for an Executor that does not try to do things (and succeeds). There is no good to be gotten from an Executor with harebrained ideas (soda-pop in the water fountains, etc) or from an Executor whose sincerity there is reason to doubt. Mr Jerrems is a leader with definite direction; he is clearheaded (not airy); and if there is anything we can not doubt—it is his sincerity.

His record screams for itself; in particular, please look at the report from the Budget Review Committee (posted on the Delegate Council Bulletin Board) This may be one of the most important projects of his administration and of the Delegate Councils of the past few years. Mr Jerrems played a prominent part in the organization, research, and presentation of this committee report. I urge you to allow him to continue as Executor.



IN SLECTION: THE PRESIDENT'S

In the past few weeks, several suggestions have been made about RAM Film Club. Originally I favored the proposal to let a private party show movies-and to possibly make a profit for himself. After talking with other students, I became convinced that this would not work. Showing movies is a service that students in the past-through RAM-have provided free of charge to the St John's community.

Right now RAM has financial problems. RAM has been burdened with paying for movies which were shown in the 1974-75 school year. In addition, RAM has run up a debt of almost \$300. Unless the receipts from movies during the rest of the school year drastically increase, money will have to be taken from some clubs. These bills must be promptly paid. I wish to be re-elected President in We have to decide now how to handle this debt and to also prevent this from happening again next year. One possibility is to keep RAM as a club, but to make some changes in its charter. Another suggestion I received is to limit the cost of the films ordered to a certain amount. This amount could be agreed on through discussion between the Delegate Council and the RAM chairmen. Someone else is suggesting that RAM be made a committee of the Delegate Council. If you have any suggestions, give them either to me or any member of the DC.

Another thing we've been working on this semester is the proposed budget for student activities next year. A copy of this budget was published in the COLLEGIAN on February 29. One of the requests in this budget, the request for money to renovate Campbell Kitchen, has already been taken care of. A new stove, \$75 worth of cooking utensils, and shelving have been installed. In addition, Campbell Kitchen is scheduled to be repainted this summer.

Another request in the proposed student budget is for a new allocation for the Student Life Committee. The SLC has been very successful this year in providing trips to various plays and other cultural events in Washington. There have been five such trips this year and we based our budget request on having gathering together, but for now tell me nine trips next year.

In the proposed budget, a larger allocation has been set aside for the Darkroom. Basic supplies such as paper and chemicals as well as elementary instruc. tion will be provided for beginners,

Earlier this year, a student committee was formed to examine the College's budget. Different parts of the budget were looked at by different committees of students. Students who worked on these committees will be meeting with Mr Dunham and Mr Weigle later this year. A copy of this report has been posted on the Delegate Council Bulletin Board in the Coffee Shop. The committee is eager to hear further suggestions and comments on the report.

Comments and suggestions are also needed on the Student Manual. Later this month. the Student Manual Review Committee will be meeting with the Assistant Deans to consider proposed changes.

By working with the Delegate Council this year, I think a number of worthwhile things have been accomplished. order to keep working with the members of the DC and follow through on these projects which we have begun.

I herein announce my candidacy for the office of Student Polity President.

As I have never held the office of President, I would rather speak of the Delegate Council as a whole, which I think I am qualified to do. The present Council has proved itself to be, at least concerning important issues, inefficient. I believe this to be caused by the current President's unannounced introduction of controversial issues to a Council which is neither prepared nor qualified to deliberate upon such topics without previous consideration. A few examples of this are the smoking issue and the dissolution of RAM (which has since, however, been declared invalid). To make the discussions more coherent, to reduce the great amount of time wasted at the Council meetings, and to protect against any ill-considered decisions, it is necessary to inform the delegates in advance of any issues that may be important or controversial to the college community. (I realize, of course, that there are some cases where there is no time and/or need to proceed in this manner, which cases should be determined by the President.)

Along the same lines, I have also seen several instances in which the person or persons involved in some major decision of the Council were not invited to protect or defend themselves. I feel that the Council should not deal in this manner with the college community. The government should reflect the wishes of the governed, not force its wishes upon them.

It is everyone's responsibility to inform the Council of problems, complaints, and suggestions. It is the Council's responsibility to find solutions to those problems, to determine the feasibility of the suggestions, and to change if possible the things that cause any valid complaints.

As President, I would encourage more communication between the students and the Council itself. The announcement of controversial subjects before the fact will give any interested students the chance to attend the meeting, as well as allow the delegates to confer with their constituency and to think at leisure about the issue rather than be forced to make any rash decisions. Organization and increased communication between the students and the Council are imperative for the Council's efficacy.

I have no great ideas to suggest at this time, I have no long list of accomplishments and qualifications, I have no bad words about the other candidates. T feel that in the office of Secretary I have completely and accurately brought to the students the decisions and deliberations of the Delegate Council. As President, I would like to bring to the Council the desires and opinions of the Student Polity, and by reducing the contentious feeling I feel is now present in the meetings themselves, to make the government less an institution to be scorned and/or feared and more a pleasant community effort.

In presenting myself to the students of St John's as a candidate for President of the Student Polity I offer the following as my platform.

In general, I run in the belief that. given the amount of money at our disposal each year, more can be done for the students, both individually and as a whole. Specifically, I run first and foremost in favor of a substantial revision of the Polity budget. Mismanagement of student organizations has robbed us of a significant portion of our annual allocation (RAM alone operated at a deficit of in excess of twelve hundred dollars last year), in addition to which money has been appropriated (or, as in at least one case, not appropriated) for the coming year to several organizations without proper regard for their size or merit.

Secondly, I run in complete and active support of the "Spruiell Plan," which offers an on-campus alternative to Annabars. Such a facility could be put into full operation by the fall term and possibly on a part-time basis by Reality of this year, and at no cost to the Polity aside from a small initial loan (unlike all other student organizations this one would be entirely self-sufficient). And, in addition to providing an income for students employed there, it would serve as a source of revenue for the Polity.

I think it is generally agreed that the present administration has, in two terms, accomplished little, and that a change is now in order. And, unless one truly believes that experience is not a necessary prerequisite, neither Mr Rote nor Mr Ostrovsky can be considered as serious candidates.

Miss Lobdell, however, a drafted and, to some degree, unwilling aspirant, presents a different picture. Experienced and eminently likeable, she clearly stands as the candidate to beat. But one cannot consider experience as the only qualification, but must also examine the fruits of that experience, as well as the goals each candidate seeks to achieve. Miss Lobdell admits to having no ideas as to what she wishes to accomplish as President, and the only fruit her experience seems to have born is a series of consistently witty and well written notes in her capacity as Polity

Secretary which, while attractive, reveals no particular administrative ability but, rather, points to the advisability of re-electing her to her current office.

Some Arguements Against the Proposal Concerning RAM

To the best of my knowledge, Mr Wells is planning to submit a proposal to the Delegate Council that would call for selling RAM's movie nights to the highest bidder. The proposal would have probably been submitted at the last meeting of the delegates had there not been a question as to whether or not they were a council. I would like to outline some of the arguments against

the proposal.

The present college policy is that any student may use the auditorium for a school activity, on open dates, free of charge. This is the policy of Mr Dunham as explained to me by Mr Magee (the most current polity attorney). Mr Magee has also pointed out to me that the procedure outlined in Mr Wells' proposal would force a student, or a student group, to pay the highest possible price for a free right. This is, in his opinion, very likely a type of extortion.

Even if it is not extortion, however, it seems to be in violation of present college policy. Furthermore, as I understand the plan of the bill, the money received from the highest bidder will go immediately to pay RAM's back debts. and that 50% of all money made, by the individual buying the rights, from showing films will be given to the DC until the debt is paid entirely. But neither Mr Wells or Mr Jerrem's has stated clearly what will happen to the profits after the debt has been paid. Will the DC continue to receive some of the profits? I believe that something should be said about this by the bill's proponents.

Another argu ment against the bill is that it will cost the individual more money to show films than it is costing RAM now. For RAM, as a non-profit organization, may rent films at a lower price than any profit organization. Mr Poissonnier has told me that a film costing RAM \$50 would cost a profit making organization \$75 to \$100 or 50% of the profits (whichever is higher), because of the scale used by the companies renting films. This casts some doubt on the whole procedure and the practicality of the plan outlined in the proposal.

A final arguement against the proposal is that it entirely removes another important part of student life on this campus from the direct control of the student body-namely, the type of films which would be shown here. I know that it can be argued that students can influence, and in part control, an individual showing films for profit, by the power of their purses. Besides the fact that this would work most efficiently only in a highly competitive market system (which, of course, would not exist in regard to films at St John's), I believe that direct control by the DC or by representatives appointed by the DC would function more quickly and more efficiently in giving students the types of films they want. So I suggest as an alternative to Mr Wells' proposal that the DC and the chairmen of RAM, Mr Poissonnier and Ms Tamlyn, work out a plan for restructuring RAM; possible placing RAM's budget directly under the control of the Polity treasurer, and eliminate the democratic element in RAM's charter, replacing it with a committee established by the DC.

At the last Delegate Council Meeting the officers of the council were let in on the fact that an election was supposed to have been held—according to the constitution—a month ago. This was brought to their attention by parties interested in having the dissolution of RAM declared illegal. None of the officers were quite clear on what their status was so Mr Jerrems thought it would be best to 'pretend' that no council action had taken place since the first fortnight in March. In this action, Mr Jerrems was wrong.

The Polity Court is the only body designated in the constitution that can declare council action invalid. The Delegate Council can only repeal its own actions by the same procedure by which they were passed. Also, only the court can determine if the council was in order illegally.

With the situation as it stands, there are some questions that need to be answered: are the motions passed by the council since the first fortnight in March illegal; were the officers of the council illegally seated; and can the up-coming elections be contested because of the missed election date?

As stated above, only the court can declare council actions illegal. Therefore, all action by the council since the beginning of March is assumed to be legal until declared otherwise by the Polity Court. This means, among other things, that RAM is still dissolved. To re-establish RAM, and change any other action taken during the period under question, the council must either pass an act in the usual legislative fashion, or, a case could be brought before the Polity Court asking for a determination of the legality of the council's actions since the first fortnight in March. This requires an answer to the second question listed

According to the constitution, elections are to be held in the first fortnight of March. The term of the officers is described as being "approximately onehalf an academic year." Also, the constitution states that the candidate who receives the plurality of the votes (subject to certain provisions) shall be elected and not until this time is the rormer officer relieved of his position. Therefore, the terms of the officers

ends when the definitive results of the election are known. This means the current officers of the council are still in power whether they are aware of it or not.

Now a question of ambiguity arises. Does this mean that the polity officers can remain in office indefinitely if the Chief Justice does not hold elections? 'Fraid so, folks. The only time limit provided in the constitution is the one-half year term designation. It would take a ruling of the court to determine what this phrase means, or even if its meaningful. The constitution is written to allow for a certain amount of dynamic leeway, as all fair documents are. The polity has placed a trust in the constitution and therefore in the officers who represent it. If the trust is returned then there is smooth governing under the constitution. If not, then a change must occur. If it is made impossible to change conditions through legal means by being restrained by elected officers then the polity has the right to revolt, or in our small case, appeal to a higher authority—the administration.

Now I come to the third and most important question: can the up-coming elections be contested or, more precisely, are there grounds for contention? The only grounds to bring a case to court on is the missing of the March election date. Not knowing everyone in this school I can only conjecture that some losing candidate might bring this case to court. But already this is a mute point. The March election date is forever gone and there is no way the power of the court can run us through it again. A woman's love is reversible, but time is not. The most the court could do is extend its sympathy to the loser and suggest an amendment to the consitution.

Needless to say, this is my interpretation of the constitution but I see no other way to view the present circumstances. The best course of action now is to get the student government back to being a smoothly functioning body. They should also re-consider all action the Delegate Council has taken in the last month and vote again to confirm their earlier actions and to place these actions beyond questioning on this matter. Delegate Council Meeting-Tues, April 6

Ms Tamlyn, Mr Tamlyn, Mr Poissonier. and Mr Woolwine, representing RAM, informed the Delegate Council of the election procedure delineated in the Constitution: "The term of office for the President (Secretary & Treasurer) shall be approximately one-half an academic year. Elections shall be held in the first fortnight of November and the first fortnight of March under the supervision of an Elections Committee appointed and chaired by the Chief Justice of the Polity Court." (Emphasis is that of the council secretary—Ed.) It appears, therefore, that these are the invalid notes of an invalid council meeting taken by an invalid secretary,

There was a lengthy discussion concerning this slightly embarrassing situation but I shall not go into the details as nothing was, or could be, decided upon. The aforementioned RAM's brought this to the attention of the council because of last week's (infamous) legislation to abolish their organization.

Mr Jerrem's final comment was to suggest that the discussion be terminated, because any vote the council might make might be invalid. The conclusion? "Let's call everything to a halt and pretend that we did nothing to RAM. Let them continue as before. When we have a new council, then we can decide what to do with RAM."

The council was then adjourned until new officers are elected, at which time the new council will re-examine and revote all legislation that was considered during the period in question.


